- 4.1 North Wiltshire District Council (NWDC) had previously appointed five people to the CBLC board. The power of appointment is delegated to the Chippenham Area (3) Committee. The appointments made by the Committee are not representatives of NWDC.
- 4.2 The CBLC have recently changed their Constitution so that the number of NWDC appointments is reduced to three. A maximum of two appointments may be serving NWDC Councillors. Councillors R.B. MacGregor and C. Crisp are appointed till May 2008. Therefore the appointment to the one vacancy may not be filled by a serving NWDC Councillor. Curtailing the number of serving NWDC Councillors from a practical point of view reduces the likelihood of conflicts of interest.
- 4.3 Barbara Oately, who was appointed by the Chippenham Area (3) Committee in 2002, has stated that she would like to be considered for re-appointment. CBLC have stated that neither Maureen Lloyd or Ann Lightfoot would like to be considered.
