Kington St Michael parish plan committee consulted widely within the community. The Recreation field was identified as a hugely significant resource providing an important amenity for all ages. From the questionnaire, 66% of respondents said that they would like to see the pitch levelled.

Kington St Michael recreation field working group, a group of village volunteers, have been fundraising, supported by the village, for several years to raise money for this project to provide an outdoor facility for all. As funds are raised, these are passed onto the Parish Council, owners and managers of the site, to help with the development of each project. This system has worked very successfully allowing everyone to be involved, as well as allowing the various projects to take place in shorter timescale than might otherwise be possible with just Parish Council Funding.

It is hoped that this project can be jointly funded by the Parish Council and North Wilts District Council.
