Doorway has a good track record of providing arts and educational activities which build self esteem and teach new skills as a first step towards moving on from homelessness etc. the community benefits from a reduction in begging and violent and drug-related crime committed by our guests most of whom are homeless and have complex needs, such as mental ill health, lack of basic skills or substance use. around 200 indiiduals used the centre last year and around 25 took part in the structured activities offered by the centre. Project outputs last year included an exhibition of arts project work, entitled 'Pictures and Words' which has been exhibited at various venues in the district to raise awareness in the community of the issues faced by homeless adults and what can be done to support them and help them move on in their lives. This year we are seeking funding to develop our very popular music programme, which will involve about 15 of our guests, and we will use information and images from this programme on our website and in other media to continue to educate and inform our community of the positive changes that can be achieved. | | | | | | |

Doorway is named in the Draft Community Strategy Action Plan for N Wilts in sections dealing with Education Skills and Learning (improved basic/life skillsof vulnerable members of the community) and Crime and Commuity Protection (supporting implementation of crime, disorder and drugs misuse reduction). Many of our guests lack the confidence to enrol on formal education and training courses, but are happy to engage with arts and music sessions at the centre. Last year around 25 took part in structured activities and all showed signs of improved self esteem, which is often the first step towards taking control of their lives. One former heroin addict is now studying music at Chippenham College after attending music workshops and weekly tuition at the drop-in. With the help of musician and teacher, Al Summers, and a volunteer we wish to develop the music programme at the centre and hope to purchase additional musical instruments and accessories to extend the range of the musical experience we can offer. (at the moment we have a drum kit and 6 accoustic guitars)
