What is the Community benefit of your project, and approximately how many people will benefit? What is the Community benefit of your project, and approximately how many people will benefit? The programme provides information and skills training on what a healthy relationship is, how to form and maintain relationships and how to manage relationship breakdown. The material fits into the PSHE curriculum requirements but in addition, enhances school policies to create a respectful and caring school community. By tackling relationship questions at a personal level with pupils in an independent, creative and non-judgmental way, we aim to increase their knowledge, improve their skills and promote self-respect, consideration of others and the valuing of diversity. The programme will also create opportunities to challenge subjects such as bullying, domestic abuse and violence; at the same time ensuring that pupils who are affected by these issues have appropriate routes for support, through our existing counseling services. The programme will target approximately 600 pupils, indirectly this may benefit up to 1800 family members, and 1800 peers in the school and community. It may also impact significantly on up to 2000 future partners and children. Our programme will have a wider positive impact on the local community by: Improved understanding by young people of parents' relationships, breakdowns and endings. Increase opportunities for young people of families to ask for or access support. Promoting dialogue on relationship issues within none school peer groups and families. Reducing likelihood of relationship crisis in adulthood; in turn modeling healthier relationships for the next generation.

In our experience of delivering counselling services in secondary schools, tapered funding, does eventually lead to the school underpinning the service. In the meantime we shall build on the support of Trusts to provide fianancial support over a three year taper period.

3 – Additional information to support and strengthen your application e.g consultation, community involvement, energy efficiency measures

Our counselling experience with young people in schools has informed us that 40% of pupils who seek support have issues that emanate from a bullying and/or domestic violence background. Last year this equated to 41 out of the 104 pupils seen in secondary schools in Chippenham. Young people who have witnessed violence or abuse in their parents' relationships can assume that such behaviour is 'normal' and apply it in forming their own relationships. We are keen to take a proactive role in encouraging healthy relationships amongst young people.

We have been providing a counseling service in Hardenhuish School for in excess of 7 years, and the school is very keen to pilot this new programme.

Swindon & Wiltshire Community Foundation have already committed funding of £1,735 for year 2 of this project.
