What is the Community benefit of your project, and approximately how many people will benefit? Yatton Keynell has a population of 1,000 living in 340 households - currently there are no outside recreational facilities for any age group. In addition to our parish population the planned project is sited adjacent to an area Primary School of around 100 pupils and the Village Hall - the users of which provide a wide area 5/6 village community service through the likes of 2x pre-School groups; Brownies; Youth Club; Indoor sporting activities and Pensioners Luncheon club. 'The Ages of Man' scheme is as a result of a parish wide facility requirement questionnaire and comprises: Toddler/Teenage Playground; Multi-Sport Court (MUGA); Child & Adult Trim Trail; Teen Shelter and an off road jogging track. Being adjacent to the Village Hall there already exists safe Car Parking facilities and established on foot access - which we fully believe will encourage potential users of all ages and abilities to come and utilise the outdoor facilities and widen the Community Spirit with youngsters and adults working together.

We have letters of endorsement for our proposed scheme from: local Doctor; Community Police; Toddler group; Brownies; Youth Club; School; Parish Council and through the questionnaire our community.

It is our intention to involve young people in the installation of our facilities to ensure that they realise it is their property to use and enjoy. When completed 'THE AGES OF MAN' will provide an exciting and safe environment for our local groups; local children and local community at large
