What is the Community benefit of your project, and approximately how many people will benefit?  Waste Not Want Not wishes to secure funding to help publicise the extension of its client base to include all Senior Citizens (previously only OAP's on Pension Credit were allowed to purchase goods).					
From regular dealings with the elderly, many are on the border line of qualifying for Pension Credit and few are cash rich, even if they own their own properties. Therefore, many senior people stuggle to replace the home neccessities when required which can have a detrimental impact on their quality of life.					
By extending its client base, as described above, Waste Not Want Not should be able to help a much larger section of the 25,000 people aged 60 or over, resident in North Wiltshire, achieve a more pleasant and comfortable lifestyle. (2001 Census showed 24,339 over 60's)					
Waste Not Want Not wishes to publicise the extension of its client base as widely and as quickly as possible. To achieve this the project is seeking funding to cover the likely cost of advertising in local magazines, parish publications and 'free' newspapers.					
WNWN currently covers 85% of its cost through the sale of goods with the shortfall being met by third party funders such as Chippenham Borough Lands Charity and Westlea Housing. WNWN aims to be self sufficent by increasing sales over a period of time without the need to increase prices beyond the reach of those that the charity is trying to help.
