What is the Community benefit of your project, and approximately how many people will benefit? As the home of Chippenham Town Bowls, Cricket, Men's Hockey, Ladies Hockey, Tennis, Harriers, and Homing Pigeon Clubs, Chippenham Sports Club currently provides a wide range of opportunities to engage in physical, recreational and social activity. It does so across a membership whose ages range from 5 to 70 plus years and, therefore, provides considerable benefit to the community in terms of health and social development. By providing an additional facility which, being undercover, can be used independent of weather conditions, the project will enable the Club to extend the range of activities it offers and the period of time it can offer them. Netball will be one of the prime sports targeted. Chippenham Netball Club, who are currently homeless and have to train wherever they can, have already committed themselves to use of the facility. They have qualified coaches and plan to run courses with the aim of expanding their membership and increasing levels of participation.						
Calne and Corsham Netball Clubs are in a similar position and would also be offered the use of the facility. The Sports Clubs further intend to organise indoor 5 a side football competitions catering for different abilities and ages from youths to veterans; and to provide facilities for such sports as basketball, in line roller hockey and volley ball as well as indoor cricket and tennis. It will be offered to primary schools in the area who may wish for, but do not currently have, access to a large hall. It would also be offered to community organisations such as Westlea in supporting social inclusion, Connexions and the Youth Development Service. It would provide a venue for other activities such as pilates, yoga, dance, chair/wheelchair based activities and after school clubs etc. It is expected that up to 500 new participants of all ages and abilities will use the facility on a regular basis.

3 – Additional information to support and strengthen your application e.g consultation, community involvement, energy efficiency measures

Representatives of Chippenham Sports Club have been working with officers from North Wilts District Council, Sport England and the Wiltshire County Sports Partnership to make the case for the Club to become one of just two proposed "Hub Clubs" for Wiltshire. Sport England has recognised the strength of the case by inviting the Club to bid for grants of up to £100,000 for capital and up to £25,000 for Revenue. However, in accordance with Sport England's declared policy, it expects a major portion of the cost of the project concerned to be found from other sources. In addition to this application for funding, the Sports Club is in the process of approaching other organisations, including Chippenham Town Council, the Borough Lands Trust, Awards for all, Westlea Housing Association, Community First under the landfill credit scheme. The governing bodies of sports expected to use the facility and possible commercial sponsors. The Sports Club also expects to take out a bank loan to cover the balance of cost.
