Although based in North Wraxall Parish, the film society is being promoted to many nearby villages within the area bounded approximately by the M4, A46, A4 and A350. The trial screening, held on 6th May at North Wraxall's New Hall, demonstrated support for the venture with 30 people in attendance from North Wraxall and surrounding villages, and voting in favour of a new local film society. A group of local people have formed a committee to share responsibilities and a bank account has been opened for membership fees and guest payments. The film society is launched on 15th July 2008 and, in the short term, is able to borrow/hire screening equipment to show monthly films. We are aiming for a membership of at least 50 people and a regular audience of 30+. However, without our own equipment, it will be difficult, if not impossible, to sustain the society into the longer term as hire costs are steep and the goodwill of others will be severely tested. Not only will the society benefit film goes, it will be designed as a social event with complimentary tea & coffee, conversation & discussion time and the occasional themed meal, bringing local people together. It will also use the New Hall and enhance its facilities allowing it to be used for children's film shows, talk and slide shows and any other events requiring high quality sound or visual facilities.
