The cage fits around a cricket pitch and enables young players to bowl and bat in a safe environment without the need to fetch any balls that are hit far away. This helps to focus their concentration and prevents frustration and boredom creeping in from having to go and fetch balls. It will also act to encourage more young players down to the club when they see better training facilities being provided. NWDC will not meet future running costs for projects.
