At the present time Box has a serious problem with youngsters driving round the car park at high speeds and using it as an area for hand brake turns which affects community safety and also discourages people from using the car park for the purpose it is intended. By resurfacing this area and redesigning the lay out of the car park, the Parish Council will create a better facility and also discourage misuse. The new sports/community pavilion is being built nearby and the projected use of this building will impact on the use of the car park. This improvement will benefit the large number of people who will use this building together with the existing people who use the recreation ground and the Selwyn Hall.


