The event will provide a rare opportunity for young children to not only watch demonstrations from professional coaches but also give them a chance to participate in coaching sessions themselves, with parental consent. Young children from Corsham/Calne/Chippenham will be encouraged to attend and we will be aiming for around 200-300. The activities include: climbing walls, parkour, bike tricks training, ultimate frisbee, triball, skateboarding and BMX. We understand what the young people of our community want today and how we can provide, with their help, an event which will bring them together with the community as a whole. We think we will reach even more adults, through the children, to demonstrate the kind of interests in physical activity that young children can have. Young people are very involved in this event; taking on specific roles in the planning, setting up and operation. We believe that this is an opportunity for young people to experience these roles first hand and put them into practice - running community groups and future community events. Providing vital experience which will help them in their future careers. The event will provide children with the chance to make healthier lifestyle choices which may well influence their peers/siblings/parents.

After the Corsham Youth Festival in May 05, WCC collated information from questionnaires, surveys and youth groups. The young people of Corsham feel there are not enough activity focused events running locally. Locality Young People Issues Groups discussed what young people would like to see in 2007 and this type of event/activities was requested. The local community have also taken part in a survey which reflects the people's needs for activities/facilities for young people. In 2006 the young people of Corsham part financed a Skate Park where up to 100 people meet to take part or watch the skate boarding activities. To follow up we ran a CASE event last year and this was extremely successful. We are repeating the event, but also want to run a mini-CASE to target primary age children - as requested by them. This new event is aimed specifically at all young (age 4-11) children in 3 large community areas and encouraging them to take part in alternative sports. The event is free to all children. We will publicise the event through all the schools via the fully supportive SSCO. Young people are helping us organise the event and on the day itself there will be a number of young people helping with the administration of parental consents. We plan to provide healthy food options. This event will provide children with the opportunity to find something of interest to them that are not necessarily the traditional sports, but are still healthy and active.
