8. NOTICE OF MOTION - COUNCIL PROCEDURE RULE NO. 11

In accordance with Council Procedure Rule No. 11, Councillor C P Humphries, supported by Councillor K R F Beard, has submitted the following Notice of Motion:

In the light of strong and persistent environmental health concerns expressed by the community in urban areas about the erection of telecom masts and base stations; that

 this council writes to the Deputy Prime Minister asking for an urgent review of Government policy with the objective of removing the apparent presumption in favour of the erection of masts and base stations in areas of high population density, particularly in the immediate vicinity of homes, schools and health care facilities. Failing this, that the government affords more weight to perceived health concerns of residents as a material consideration in the planning process as suggested in PPG8 paragraph 29:

" 29. Health considerations and public concern can in principle be material considerations in determining applications for planning permission and prior approval. Whether such matters are material in a particular case is ultimately a matter for the courts. It is for the decision maker (usually the local planning authority) to determine what weight to attach to such considerations in any particular case"; and

 officers be instructed to prepare a policy in our local development documents that will resist the erection of masts and base stations near homes, hospitals and schools, and require mast operators to demonstrate that there is no alternative location to site masts and base stations outside urban areas.
