1. Introduction

1.1 The purpose of this report is to recommend a draft calendar of meetings for the 2008/2009 municipal year.

2. Options

2.1 Council could decide to approve meeting dates different to those contained in the appendix to the report.

3. Background Information

- 3.1 The calendar of meetings has been produced in consultation with senior officers, group leaders and other local authorities. Efforts have been made to avoid meetings within the Liberal Democrat Conference Week (13 to 17 September 2008), Conservative Conference Week (28 September to 1 October 2008) and school holidays (highlighted in yellow) as far as possible.
- 3.2 Committee cycles have been structured to allow easy reporting between Overview & Scrutiny, Executive and Council.
- 3.3 This year the Calendar of Meetings ends on 31 March 2009 as the new unitary authority, Wiltshire Council, will come into existence on 1 April 2009.
- 3.4 The dates for Area Committees remain in the Calendar at this stage pending final decisions on the piloting of Area Boards within North Wiltshire. It is likely that the current Area Committees will continue until such time as the pilot Area Boards can be implemented.
- 3.5 The Executive budget meetings in December and January have been removed as the Council is not required to set a budget during its final year of operation.

4. Legal Implications

4.1 The calendar is approved for administrative planning purposes and will not be formally adopted until the Annual Meeting of the Council in May 2008.

5. Community and Environmental Implications

5.1 Members have expressed the importance of holding Area Committee meetings in their respective communities. Once the calendar has been approved officers will seek to apportion bookings to different communities on a fair basis if practicable.

6. Equality and Diversity Implications

6.1 The majority of meetings are held in the evening and steps are taken to avoid meeting during school holidays to enable wider attendance at meetings.
