Many people complement us on the appearance of the cemetery it is a beautiful setting, very tranquil and peaceful and home to a lot of wild life. We aim to continue to provide a well cared for area which local residents can seek comfort and peace from in difficult times and to simply enjoy at other times. The upkeep and care of the cemetery is ongoing and has been the responsibility of the Parish Council for some 30 years. Local residents expect us to maintain a high standard we know from experience that managing a cemetery is a very sensitive issue in particular with health and safety issues that arise. We are quickly informed if all is not well in the cemetery such as when flowers go missing and people are distressed thinking vandalism has occurred or even that their family grave has been targeted for some mischievous reason or pots go missing or even on occasions when grass has been left stuck to a memorial after it has been cut.

With regard to the work we propose we have not conducted any survey etc to gauge the views of local residents in that the work is that of common sense and basic practicalities we have however informed residents of our plans and we have not received any negative comments on the proposals.
