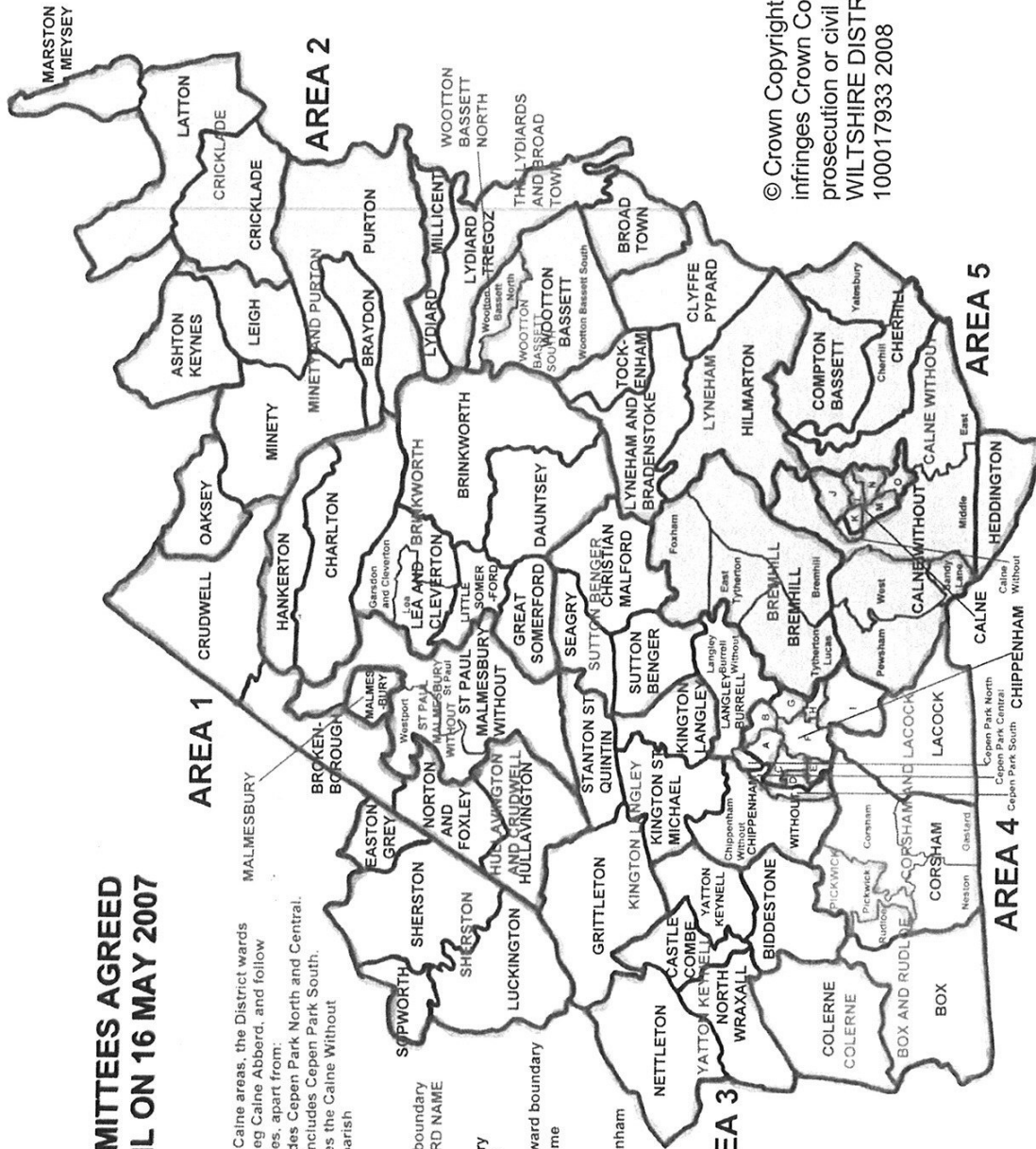
In the Chippenham and Calne areas, the District wards include the town name, eg Calne Abberd, and follow the town ward boundaries, apart from:
