CR41. Apologies for Absence

CR42. Public Questions/Receipt of Petitions

(a) <u>Development Control Procedure</u>

Mr Peter Colmer from Cricklade Town Council asked a question regarding the arrangements for making development control decisions during the interim period between 1 April and June 2009. It appeared that local residents would not be able to call in decisions as they had done in the past. Previously if five objections were received to an application it would be referred to the Development Control Committee.

Councillor A Bucknell explained that a procedure for dealing with such decisions had been agreed by the Implementation Executive but that this could be reviewed in due course by the new Council. Wiltshire County Council had consulted on the proposals.
