(a) Withdrawn Items

(b) Planning Applications

Note: In making the following decisions, the Committee took into account observations by Local Councils and interested parties received subsequent to the preparation of the Agenda and given in the Additional Information Schedule circulated at the meeting. A copy of the Additional Information Schedule is kept in the official Minute Book.

1. 08/00445/S73A – Separation of annexe type accommodation from dwelling (removal of condition 4 of 04/00124/COU) – "Garden House", 46a High Street, Corsham

Representations were received from Mr J Spikes (the Applicant) and Mr N Keyworth in support of the application and from Mr A Howard (the Agent).

Issues discussed included:

- The view that the proposal would not allow sufficient parking space for each house; and
- The condition attached to the original planning application specifically disallowed such a separation in order to protect the setting of the listed building.

**Resolved** that authority be DELEGATED to the Development Control Manager to REFUSE Planning Permission for reasons 1. as below and 2. if this is supported by Wiltshire County Council following consultation on amended plans:

- 1. Notwithstanding its lawful use as ancillary domestic accommodation, due to its very close proximity to No.46 and associated severance of the curtilage, the use of this building as a separate dwelling would not only represent an unacceptable intensification of activity on the site but would also lead to the certain proliferation of domestic paraphernalia that would harm the setting of the listed building and amenities of occupiers therein. As such, the proposal is considered to be contrary to the provisions of Policies C3 and HE4 of the adopted North Wiltshire Local Plan 2011; and
- 2. In light of the limited parking facilities available on the site, the proposed use of the accommodation presently annexed to "Rowan House" as a separate unit of residential accommodation, is likely to give rise to the onstreet parking of additional cars attached to the premises and thereby interrupt the free flow of traffic to the danger of road users in an area which is already congested with on-street parking.
- 2. N.08.0680.FUL Erection of Dwelling with Associated Garage, Landscaping and Vehicular Access (Resubmission) 55 Bradenstoke, Nr Chippenham, Wiltshire, SN15 4ES

Representations were received from Mr Warren in objection to the application and from Councillor J Webb (Lyneham and Bradenstoke Parish Council).

Issues discussed included:

- That previous planning applications for this land had been refused due to the previous applicant being unwilling to pay the necessary contributions; and
- The necessity of appropriate design for housing in conservation areas.

**Resolved** that the decision be DELEGATED to the

Development Control Manager to await consultation comments and subject to no further objections being received, the applicant be invited to enter an Agreement in respect of the following matters:

- 1. Open space Contribution
- 2. Affordable Housing Contribution

following completion of which the Development Control Manager be authorised to GRANT Planning Permission.

# 3. 08/00745/FUL – Erection of Detached Dwelling following Demolition of Existing Garage – 6 College Road, Purton

A Representation was received from Mr M Willis (the Agent).

**Resolved** that Planning Permission be GRANTED subject to the conditions set out in the Agenda and the additional condition set out in the Additional Information.

## 5. 08/01051/FUL – Detached Garage – Cooles Cottage, Minety

A representation was received from Mr M Robinson (the Agent).

Issues discussed included:

 The new build of both house and garage (partial) was considered to be of a high specification.

**Resolved** that authority be DELEGATED to the Development Control Manager to invite the applicant to amend the application to include a change of use of the land to curtilage.
