- 11. &12. 0808/01461/FUL Internal and External Alterations Associated with Conversion to Community & Leisure Use; Erection of Two Extensions and Change of Use from Agricultural to Community and Leisure Use and Erection of Two Extensions, The Cart Shed, Derriads Farm, Derriads Lane, Chippenham

Representations were received from Mr N. Stewart, Mrs C. Pugh, Mrs Smithers and Mr A. Barnes in objection to the application and from Mr P. Reynolds of Chippenham Without Parish Council.

Issues discussed during consideration of this item included:

**Resolved** that the applications be REFUSED for the following reasons:

In respect of 08/01968/LBC

1. By reason of the scale and extent of proposed extensions and car parking, is considered that the proposed development would neither preserve or enhance the existing barn or its setting within the Derriads Farm complex, which is Grade II listed. As such the proposal is considered to be contrary to the requirements of Policy HE4 of the adopted North Wiltshire Local Plan 2011.

In respect of 08/01969/COU:

2. By reason of the scale and siting of proposed extension and car parking, together with its proximity to adjoining residential properties, it is considered that the proposed use of the barn for community and leisure activities is likely to give rise to an excessive level of noise and forms of intrusion to the amenities of the occupants of neighbouring residential properties. As such the proposal is considered to be contrary to the requirements of Policy C3 of the adopted North Wiltshire Local Plan 2011.

- 3. By reason of the scale and extent of proposed extensions and car parking, it is considered that the proposed development would neither preserve or enhance the existing barn or its setting within the Derriads Farm complex, which is Grade II listed. As such the proposal is considered to be contrary to the requirements of Policy HE4 of the adopted North Wiltshire Local Plan 2011.
- 13. 08/01388/FUL Demolition of Existing Stables, Erection of 5 Stables, Storage and Caravan for Storage on Site and Change of Use of Land for the Keeping of Horses Pooks Hill Lane, Heddington, Calne
