What does your project aim to achieve?						

It will provide the final facility in our plans for a holistic approach to increasing participation in all sports and youth activities in the village of box. We are working and developing partnerships with Box Primary School, and through specific plans the bowls, tennis, football and rugby organisations. It will form a base of our developing youth club, linked to our targeted action plan for this vulnerable part of our community. It will embrace all ages in the community and ensure increasing opportunity for participation in sport and help address the needs of young people.

The existing pavilion in Box has come to the end of its life and needs replacement. It is mainly used by the bowls club, but its design and age really restricts its use by other organisations. A range of other sports and leisure organisations, particularly targeted at growing the youth sections, will use the new facility. Box, like a number of villages, have a problem with activities for young people, so an investment of this type will have long-term benefits.

There is a vigorous and growing youth club, which will use the new facilities. It is ideally placed on the edge of the recreation field for indoor and outdoor activities. The tennis club has the commitment of a new youth coach for our young people. The football club has been in decline but more recently is showing signs of revival and will use the new changing facilities. We are also in discussions with a rugby coach and the local primary school to extend usage of the proposed facilities. Linking this with the basketball facilities and a vibrant bowls club that is also developing a youth development programme and you have a potential vibrant village facility in the centre of the village of Box.

We are putting together a package of funding to support the estimated costs of some £350, 000. We are currently at least some £80,000 short. Funding would not be required until spring 2006 and can be spread over two financial years.

This is a project that would make a real difference to particularly young people in Box.

- 1. The application is being led by the Parish Council, who set up a charity to run the recreation facilities. Graham Cogswell is the project manager and we have a management group pulling the project together.
- 2. An original application to Sports England received an invitation to proceed to a full application, as the project meets objectives set in their regional plan. A full application was made in February 2005. This was rejected following a change in the lottery criteria and priority given to other schemes. Other grant sources are being actively pursued
- 3. There is a village hall called the Selwyn Hall and a cricket pavilion just set off the recreation field. The existing bowls pavilion has come to the end of its life and the opportunity is being taken to provide facilities for bowls, tennis, football, mini-rugby and a youth club.
- 4. The Parish Council has set some moneys aside as has the sports clubs.

Planning permission has been received for a pavilion on this site. I have spoken to a Planning Officer and there would be no problem obtaining permission for an increased building.

Hire income and fund raising from user clubs and organisations. Business plan identifies running costs of £6,000 and potential income committed at this stage of £3,000. Occasional lettings and fund raising has not been allowed for in these calculations. The Parish Council has agreed to underwrite any shortfall.

A copy of the business plan is enclosed showing that this should be self-supporting after two years

How will this project benefit local people and approximately how many will benefit?

The pavilion will be a youth club and a sporting HQ particularly for bowls, tennis and football and with time rugby. Bowls (100), Tennis (25), Football (35), Youth Club (25) and Box School (250) i.e. 435 immediately and directly. We have development plans to increase these numbers particularly targeted at young people to an additional 70 in two years. We also believe that the enhanced facilities will give greater access and opportunity to a further 3,000 in the village.

Section 3 – Additional information to support your application e.g. consultation & community involvement

A recent survey of village facilities by Sport England identified this facility as a critical gap.

A presentation of the project to the annual Parish meeting in April 05 was very well received with vigorous support from a large attendance.

Extensive miscellaneous funding is being sought. A meeting has been held with a representative from the Charities Information Bureau to help identify as many areas of potential funding as possible. There is also input from Graham Harris of the Wiltshire & Swindon External Funding Network. An application has been sent to the Foundation for Sports and the Arts but no decision has been made. Other areas being targeted are the various Sports Association; Awards for All; Tesco Charity Trust; Sainsbury; SWEET; Lloyds tsb; The Baring Foundation etc. and an application will be made to the Big Lottery early next year under the new heading of Community Buildings. Two books entitled "The Sports Funding Guide" and the "Youth Funding Guide" have been purchased from the Directory of Social Change and all possible Charities have been identified.

An application for a substantial contribution will be made to the Big lottery early new year under the new heading of Community Buildings.
