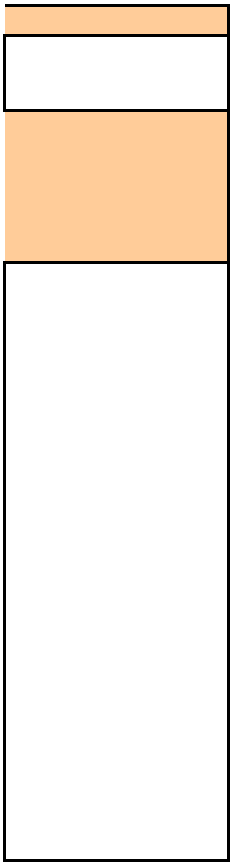


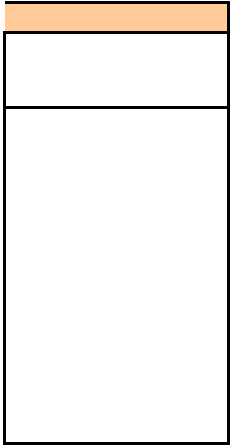

Much excellent take up activity has already taken place; it is therefore unlikely that such a rate of increase in take up can be sustained. 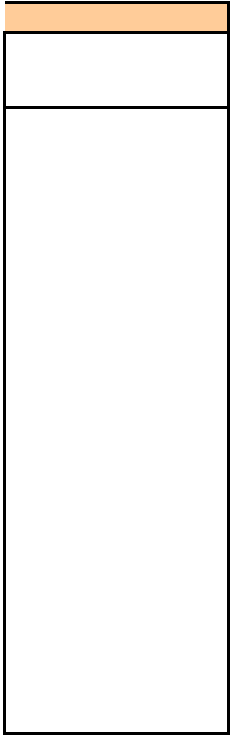

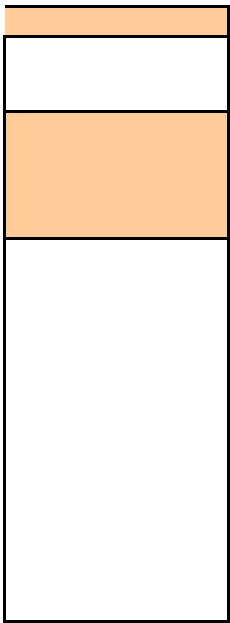

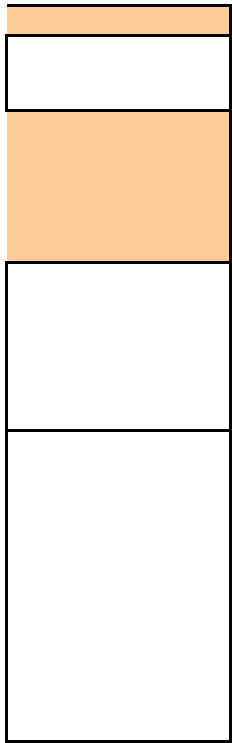
