#### Introduction

Children and Young People's services nationally continue to go through extensive reform, underpinned by the Every Child Matters and the subsequent Youth Matters agenda. This Youth Strategy sets out the needs for the young people living in North Wiltshire.

The strategy covers the priorities identified by young people themselves through active engagement and consultation and reflects the services and opportunities for young people aged 13-19. This is not a Children's plan and does not reflect the entire scope of services available for children and young people, their parents and carers. It is a demonstration of the commitment of North Wiltshire District Council to listen to and value the voices of local young people and respond to their suggestions on how to increase opportunities and positive outcomes for the young people of North Wiltshire.

North Wiltshire District Council aims to embed the needs of young people throughout strategic and policy development and therefore further information on services for young people can be found in the:

- Play Strategy
- Community Strategy
- Local Community Plans
- Community Safety Strategy
- First Active Strategy

Actions set out in the Youth Strategy will underpin the Council's corporate priorities for Young People through the Corporate Plan and the Transition Plan towards One Council for Wiltshire.

### **Young People in North Wiltshire**

Following extensive consultation most young people agreed with the statement, 'North Wiltshire is a good place for young people to live' in comparison to other parts of the country. They felt it was a relatively safe place to live and socialise. Many young people however, felt there was very little for young people to do, very few youth clubs and facilities. There is a feeling amongst young people that having in place appropriate and easily accessible facilities would impact on anti-social behaviour.

Young people in North Wiltshire face:

- Isolation and boredom
- Lack of choice around choosing to live in the area independent of their families, due to lack of affordable housing
- Negative perception of young people due to them 'hanging around' and 'being a nuisance'
- A high fear of crime especially after dark

#### **National Context**

#### **Every Child Matters (2003)**

In 2003 the Government publishes 'Every Child Matters', in response to unprecedented debate and consultation on the needs of and service provision for children and young people, their families and carers. The guidelines set out also secured increased welfare and protection of children and young people by outlining better ways of working for professionals through multi disciplinary teams. In March 2004 the Children's Bill was published alongside 'Every Child Matters: Next Steps', together these documents direct a co-ordinated approach to services for children and young people.

Following the consultation five headline areas were identified by children themselves and adopted as the '5 ECM' outcomes:

- Be healthy: enjoying good physical and mental health and living a health lifestyle
- Make a positive contribution: to the community and to society and not engaging in anti-social or offending behaviour
- Enjoying and achieving: getting the most out of life and developing broad skills for adulthood
- Staying safe: being protected from harm and neglect and growing up with independence
- Achieve economic wellbeing: overcoming socio-economic disadvantages to achieve their full potential

Achieving what is set out in ECM will need Considerable amendments to policy at both a national and local level , this should include:

- Better prevention
- A stronger focus on parenting and families
- Early intervention
- Improving accountability and integration
- Workforce reform

The introduction of Wiltshire's Children's Trust and it's subsequent Children's & Young People's Plan has began to address the following:

- Strategic level involvement from the Voluntary and Community Sector
- Strategic level value to the vies of children and young people
- Establish locally agreed outcomes for children and their families
- Shared planning and workforce reform
- Creation of multi disciplinary teams and co-ordinated services, operating within Children's centres, extended schools, and other community based locations
- Joint assessment of need, leading to joint commissioning of services
- Sharing information, pooling resources and budgets to aid development of shared services

Implementing the recommendations set out in Every Child Matters effectively will depend on the integration of other legislation that impact on children and young people.

#### The Local Context

Many of the services in North Wiltshire for young People provided by North Wiltshire District Council are delivered at the discretion of the political administration at the time.

The District Council works closely with the County Council to fund and provide services along with other statutory and voluntary organisations in partnership.

Because of the fragility of funding for youth provision many projects and services have a short life span and securing funding for their continuation is key to their survival.

North Wiltshire has had an active Young People's Council (YPC) since 2004, the YPC area group of 24 young people aged 13-19 from across North Wiltshire, meeting once a month to discuss issues facing young people:



- We campaign to change the negative views of Young people
- We put forward young people's views at important meetings e.g. LSP
- We talk to local politicians and decision makers
- We consult other young people through events, our schools and youth centres

The YPC links to the Wiltshire Assembly of Youth (WAY) the Countywide youth forum, which is elected by their peers from within schools and youth groups to, champion young peoples issues across the County.

There is one young person elected to represent North & West Wiltshire and one young person elected to represent Salisbury and Kennet on the UK Youth Parliament (UKYP).

North Wiltshire District Council is the only District in Wiltshire that has a designated Youth Involvement Officer who provides a coordinated approach to youth participation and ensures collaboration between the District and the County Youth Development Service Voice and Influence team.

Youth Development and Involvement in North Wiltshire continues to hailed as demonstrating best practice across the District. Research carried out to support the five Councils integration of equality standards highlighted it as exemplary in their research and was also highlighted at the recent, Equality and Quality consultation day held in Devizes Dec 07

#### **Actions for Youth**

North Wiltshire District Council works with Public, Voluntary and Community sector organisations towards individual and shared government targets to develop and deliver services for young people.

North Wiltshire District Council works in Partnership to deliver comprehensive services through a shared approach to maximise resources and avoid duplication, making information about services clear and accessible.

North Wiltshire District Council as part of its customer focussed approach works to ensure young people are able to access district council services effectively, and be able to signpost any enquires to appropriate services if young people present themselves to the Council.

North Wiltshire District Council as part of the transition to one Council ensures that issues relating to young people drawn from consultation and activities are communicated to the new emerging authority

North Wiltshire District Council continues to take up its role as a statutory partner on the Wiltshire Children & Young People's trust Board

The following action plan highlights a number of key objectives set out against the ECM outcomes addressing issues raised by young people for young people and how partners in Wiltshire will address them. As a statutory partner on the Wiltshire Children's Trust, the District Council has a responsibility to support the delivery of key actions highlighted in the Children's plan 2006-2009.
