1. Introduction

- 1.1 The report updates Members on the allocation of Affordable Housing Grant at Avonside, Chippenham where £15,000 was allocated to adapt the homeless hostel to meet the needs of single persons and in particular 16 and 17 year olds on a temporary basis (for a period of approximately 2 years) while purpose built accommodation is constructed.
- 1.2 Members asked for a monitoring report in six months.

2. Options and Options Appraisal

2.1 The report is for information only.

3. Background Information

- 3.1 Westlea Housing Association were allocated £15,000 in June 2007 for the adaptation of the former homeless persons hostel to meet the needs of single persons and in particular 16 and 17 year olds on a temporary basis (for a period of approximately 2 years) whilst purpose built accommodation is constructed.
- 3.2 At the time there were four 16/17 year olds in bed and breakfast accommodation which is unsuitable and had to be housed more adequately to ensure the Council meets its LPSA target for the reduction in the use of B&B accommodation for young people.
- 3.3 The cost of adapting the hostel was estimated at £15,000 and was necessary to create a safe and secure separate section for use by up to six, vulnerable 16 and 17-year-old persons. The grant was to be used to install security doors, CCTV, and door entry systems.
- 3.4 Following the Executive approval for the allocation of the grant Westlea commenced the final decanting of residents from Avonside. This process took until September to achieve due to the complex needs of the final residents. The scheme was then resurveyed and the cost estimate reviewed. The outcome was that further works were required to the hot water system bringing the costs up to nearly £50,000. This was deemed too expensive and the works where not undertaken.
- 3.5 Officers worked with Westlea Housing Association to look at alternative solutions that were more cost effective to meet the needs of young people.
- 3.6 Westlea Housing Association were able to offer 3 x 2 bed general needs flats (in Calne, Chippenham and Corsham) that with some alterations would meet their needs at a more reasonable cost. The first of the flats is now available for occupation and the other two will be available shortly. Avonside has now been boarded up prior to demolition and redevelopment.
