1. Introduction

- 1.1 Revenue budget monitors are produced to report on May (M2) to February (M11) of each financial year. They track progress against the agreed budget decisions, forecast any anticipated significant variances to the budget, and enable corrective action to be taken.
- 1.2 The 2008-09 budgets are split by Business Area and by Subjective as follows:

1.3 Due to year end work commitments and limited financial information available being available at this early stage, a "light touch" revenue monitor has been carried out for month 2, highlighting only major known variances against budget.


3. Background Information

- 3.1 Overall position at Month 2 there are a small number of material issues that may affect the final outturn position for 2008-09.
- 3.2 Employee costs at the current levels of employment, direct employee costs are forecast to be approximately £1.5m below budget. Indirect employee costs are currently forecast to be in the region of £1m over budget. This gives a net forecast position of circa £500k underspend on total employee costs.
- 3.3 Cleansing and Amenities after the budget setting process for 2008-09 was complete, a new pricing structure for some services was created, which has increased the expected income for the service. An additional £174k is expected due to the Trade Waste price increase, and an additional £121k is expected from increased take-up of the green waste service.

The Cleansing and Amenities budgets are currently being reworked, and some of this increased income may be re-invested as part of the on-going service improvements, however a surplus against budget is expected. An estimate of the levels of savings achievable will be included in the June monitor, taking into account hyper inflation in respect of fuel.

3.4 There are 421.7 FTE's in the budget. In May there were 361.3 FTE's employed.
