1. Introduction

1.1. This report provides feedback from the Cash for Communities budgets featured in the March Edition of Improving North Wiltshire.

2. Options and Options Appraisal

- 2.1.1. The Executive note the progress of the awards process from the Cash for Communities budgets 2008/09.

3. Background Information

- 3.1. The March edition of Improving North Wiltshire set out the opportunities which the Council would be giving local people to apply for funding to improve their communities.
- 3.2. There were many different ways in which local people and community groups could access funds by applying to the Council. As in previous years each of the Area Committees was allocated a budget to award to projects and activities within the relevant community area.
- 3.3. The Council also made specific provision for a number of key areas of community importance including CCTV, Energy Efficiency, Post Offices and Sports Activities.
- 3.4. This report focuses on providing feedback and information on awards made from the following Cash for Communities Budgets;
 - CCTV
 - Community Area Award Funding (for each of the 5 Community Areas)
 - Executive held Community Award Funding
 - Funding for additional sports activities across North Wiltshire
 - Funding Support for communities at risk of losing their Post Office Service
 - The Energy Efficiency Awards Scheme

4. Overview of Funding

4.1. The maps included in the Appendices (1-6) highlight where awards have been made from the Cash for Communities Budgets. In addition to those detailed in the paragraph above Members will note that the maps include information relating to funding that has been provided to the Council's Leisure Centres.

5. Key Funding Highlighted Areas of Focus

5.1. CCTV

5.1.1. As a part of the Council's commitment to combating vandalism and antisocial behaviour Town Councils were invited to submit proposals to install or improve CCTV schemes in their Towns. The following awards were made;

5.1.2. Five of the market towns in North Wiltshire will now have a CCTV scheme Malmesbury did not previously have any scheme. The Council has supported the capital investment required to implement and establish the schemes, each of the Towns will remain responsible for the on going running costs of the new and improved schemes.

5.2. Community Area Award Funding

- 5.2.1. Each of the Area Committees has been making awards to community projects within the relevant community area. Each Area Committee was allocated a budget of £40,000 for capital based projects and £12,000 for revenue based projects.
- 5.2.2. Each Area Committee also has an allocation of £10,000 to be spent on projects that improve the physical environment or streetscene.
- 5.2.3. In September the Executive resolved to allocate each Area Committee £10,000 from under spending in year budgets. As this is in year underspend the £10,000 can be spent on either capital or revenue projects at the discretion and priority of the Area Committee and is referred to as the project budget.
- 5.2.4. Both the maps and the detailed list of awards (at Appendix 7) show that a significant number of projects have been awarded funds in this year. As with previous years the applicants have been required to demonstrate a clear benefit to the community and a link to the relevant community plan. Members are then assured that the projects that are being funded by the Council are in line with identified community need.

5.3. Executive held Community Award Funding

- 5.3.1. Where a project is of particular significance or scale or where the communities benefitting are community wide or span across more than one community area applications for funding are considered by the Executive.
- 5.3.2. The table below details those awards made by the Executive so far this year.

5.4. Funding for additional Sports Activities Across North Wiltshire

- 5.4.1. The Council allocated an additional £30,000 to the Sports Development budget this year. The funds have been used to provide additional sports activities across the District targeted at different locations, communities and age groups. There have been a number of key events that aim to increase opportunities to access sports activities and participation.
- 5.4.2. Major events include Midsummer Bike Night at Castle Combe race circuit in June and Corsham Alternative Sports Event in September these attracted over 1500 people between the two events. Young people tried climbing, parkour, mountain biking, skateboarding and bmx-ing during a day of alternative sports activities at Corsham whilst Castle Combe saw people of all ages involved in a high quality cycling experience to celebrate National Bike Week. January will see the launch of 'Return to Sport' projects for adults and a programme of Dance in Calne and Wootton Bassett alongside the development of an alternative sports club in Chippenham.
- 5.4.3. The following list provides a summary of the activities provided to date with an indication of the levels of participants.
 - Gifted and Talented projects in Wootton Bassett and Chippenham for 6 and 7 year olds - 37 participants
 - Malmesbury and Calne Summer Holiday Activity Project 81 participants
 - CASE up to 1000 participants
 - Midsummer Bike Night 412 participants
 - Malmesbury Over 50's activity sessions 12 participants
 - Chippenham Mums and Daughters Football project 13 participants
 - Club School Link Projects Tag Rugby (District Wide) and Cricket (Malmesbury) -310 participants
 - Wootton Bassett Young People's Activity Sessions 20 participants
 - Corsham Tai Chi Project starts November, 12 participants signed up

5.5. Funding Support for communities at risk of losing their Post Office Service

- 5.5.1. This particular fund was set up by the Council to provide support to local communities where there are initiatives that could save Post Office Services that are threatened, or support alternative proposals. It was intended that this could be in the nature of some funds for initial (basic) structural works which allow for a basic Post Office service to be maintained within an existing business or community facility.
- 5.5.2. In May 2008 the Executive agreed to a proposal from Kington St Michael and awarded £2,500. Officers have been working with representatives of the Kington St Michael Village shops where there was agreement to provide postal services for the community.

5.6. The Energy Efficiency Award Scheme

- 5.6.1. This awards scheme was set up to provide grants to improve energy efficiency in buildings that are for community use for example Community or Parish halls. Expressions of interest for the scheme were sought in March and April this year.
- 5.6.2. The scheme centres around an energy efficiency audit undertaken by the Council's partner the Severn Wye Energy Agency. Each audit makes a series of recommendations for areas of improvement, these recommendations are for both physical improvements and behavioural changes. Each recommendation has been

- prioritised and has an estimated implementation cost. Facilities with a completed audit were invited to apply to the Council for funds to implement the improvements.
- 5.6.3. A total of 39 expressions of interest were completed and returned by the deadline date. Of those 39 applications 36 met the required criteria and were put forward for an energy audit.
- 5.6.4. Each of the 36 community facilities has been provided with an energy meter that will monitor usage. The project is promoting local suppliers as a means to delivering the recommended improvements by encouraging local suppliers to contact the community asset holders and provide quotations for the work.
- 5.6.5. In addition to environmental benefits from reducing carbon emissions this project should see a future reduction in the running costs of the facilities.
- 5.6.6. The table on the following page details which community facilities have been awarded funds for what energy efficiency improvement measure. The facilities are currently gathering quotations for works, once quotes have been approved the energy efficiency measures are being implemented.
