A committee was formed in June 2005 and has been actively working with the community and the Council to move the project forward.

Large numbers of local individuals and groups have helped with fund-raining which has enabled us too put in new goalposts, erect new fencing and to move forward with the 'dog ban'.

The Town Council, both individually and as a group has been very supportive of our efforts. This group and community support led to the project being awarded £50,000 from the Big Lottery Fund. Strongly involved in this bid were local schools, businesses and the wider community of Malmesbury.
