Before Burnham House closes in July 2009 and the residents move to the new Athelstan House they will be be given the opportunity to work with an artist to explore the ways that they have made Burnham House their home. Most of the residents are apprehensive about moving. Time to share some of their memories, experiences and feelings with an artist will help them to make a memento of their home in Burnham House and will be a helpful anchor when they move to the new premises. The outcome, mainly in the form of books of images and words, will be available to residents, day care visitors, staff, relatives and friends. There are 48 residents and a similar number of staff at Burnham House. There are approximately 60 day care visitors. The project will be a small acknowledgement of the community service that Burnham House has provided for the people of Malmesbury and the surrounding district for 27 years. Not only will the residents benefit from taking part in the project but if the final outcome is made available at Malmesbury library, the new health centre (the current practice has 14,000 registered patients) and the larger, new Athelstan House and day care centre it has the potential to be of benefit to many more people who may be considering moving into residential care themselves or considering it for a relative or friend NWDC will not meet future running costs for projects. "Working together to improve the quality of life for all in Malmesbury and the surrounding villages" is the vision stated in the Malmesbury Area Community Plan. The inclusion and care of the elderly is a major feature of Social Care and Health in this Community Plan. The new complex that will replace Malmesbury Hospital will include Athelstan House, a 60 bed home for the elderly. This project will provide useful support for people considering giving up their home and moving into residential care. Also the experience of taking part and the resulting images and words will be important reminiscence therapy for residents during and after the project. As part of the consultation and research to ascertain the need for the project the artist met with the manager and staff at Burnham House to outline the ideas and share a simple written proposal. The very positive response from everyone resulted in the manager volunteering to make a photocopy of the written outline for every resident to consider. Each resident has a Keyworker who took responsibility for talking through the proposal with the resident before accepting a signed response slip. Also there has been interest from relatives who would like to be involved. The artist possesses CRB Enhanced Disclosure for working at The Orders of St John Care Trust, Burnham House.
