1. Introduction

1.1 This is the first quarterly update report on the Transitional Corporate Plan to be presented to Overview & Scrutiny Committee this financial year. It covers the period 1st April to 30th June 2008. The report also includes a response to the information requests, albeit arising from last year's corporate plan, made by the Overview and Scrutiny Committee on 12th June 2008.

2. Background Information

- 2.1 The Transitional Corporate Plan focuses on three priority areas, each of which has within it a set of goals and key actions. These priorities, goals and actions were identified as a development from last year's priorities but with a particular emphasis on the transition to the new Wiltshire Authority on April 1st 2009. This is therefore the last Corporate Plan this Council will action and therefore with an increasingly short timeframe for those actions to take place.
- 2.2 The Corporate Plan is an integral part of the Council's performance management framework and its delivery forms part of the Audit Commission's annual review of the Council's "Direction of Travel" linked to the Comprehensive Performance Assessment process. Progress against the Plan is reported quarterly to the Executive and the Overview and Scrutiny Committee.
- 2.3 Appendix 1 sets out a table showing the Transitional Corporate Plan actions and progress to date. Where possible, up to date progress has been given. Any implications for the Council in terms of financial or other risk are shown in the table. Due to staff leave the report is incomplete at the time of writing in respect of those matters handled by Cleansing & Amenities. An updated report will be available by the date of the meeting.
- 2.4 Matters raised by the Overview and Scrutiny members at their meeting on the 12th of June 2008 related to last year's Corporate Plan and where these remain relevant to the Transitional Corporate Plan these have informed the commentary in the table in Appendix 2.
