# (1) K/57714/O

**MARLBOROUGH –** Marlborough Depot Site, Salisbury Road, Marlborough –outline planning permission for erection of 18 live/work units; 14 residential dwellings and associated works following the demolition of existing buildings.

**DEFERRED AND DELEGATED AS RECOMMENDED** to the Planning Services Manager to grant planning permission following completion of legal agreement subject to the additional conditions concerning the following highway matters:

- 5) Provision of a cycle/pedestrian route between the adoptable road and the existing pedestrian path on the old railway line prior to occupation of any of the units/dwellings.
