REASON: To ensure that the development harmonises with its setting.

POLICY: West Wiltshire District Plan - 1st Alteration 2004 - Policy C31A.

(6) No development, hereby permitted, shall take place until the applicants, or their agents or successors in title, have secured the implementation of a programme of archaeological work in accordance with a written scheme of investigation which has been submitted to and approved in writing by the Local Planning Authority.

REASON: To protect the archaeological heritage of the area.

POLICY: West Wiltshire District Plan - 1st Alteration - Policies C14 & C15

# Application No. 5 07/00524/FUL - St Marys Church Upton Scudamore

Permission contrary to Officer's recommendation with the following conditions:

(1) The development hereby permitted shall begin before the expiration of three years from the date of this permission.

REASON: In accordance with Section 91 of the Town & Country Planning Act 1990 as amended by Section 51 of the Planning & Compulsory Purchase Act 2004.

(2) No development shall take place until samples of the materials to be used in the construction of the external surfaces of the development hereby permitted have been submitted to and approved in writing by the Local Planning Authority. Development shall be carried out in accordance with the approved details.

REASON: To ensure that the development harmonises with its setting.

POLICY: West Wiltshire District Plan - 1st Alteration 2004 - Policies C31A.

(3) A sample wall panel, not less than 1 metre square, shall first be constructed on site and approved by the Local Planning Authority before construction proceeds. The panel shall then be left in position for comparison while the development is carried out. The development shall be carried out in accordance with the approved sample.

REASON: To ensure that the development harmonises with its setting.

POLICY: West Wiltshire District Plan - 1st Alteration 2004 - Policies C31A.

- (4) In accordance with Policies C19 and C20 of the West Wiltshire District Plan and Policies C27 and C28 of the West Wiltshire District Plan First Alteration, in order to protect the character and appearance of the listed building, no work shall commence until full detailed elevations and sections of the proposed extension, at a scale of 1:20 have been submitted to and approved by the Local Planning Authority. The details shall include:
- i) the method of attaching the extension to the existing church
- ii) the method of lighting the rose window;
- iii) the footings and/or piles and their relationship to the nearby yew tree and graves.

REASON: To ensure that the proposal harmonises with the listed building

POLICY: West Wiltshire District Plan - 1st Alteration 2004 - Policies C27 and C28

(5) In accordance with Policy C29 of the West Wiltshire District Plan and Policy C40 of the West Wiltshire District Plan - 1st Alteration (Revised Deposit), to prevent damage to the adjoining Yew tree, the foundations of the extension shall be dug by hand to avoid damaging tree roots. If any roots above 50mm in diameter are encountered they shall be retained if possible and backfilled with sharp sand around the roots before surrounding with a granular sub-base.

REASON: To ensure that the development harmonises with its setting.

POLICY: West Wiltshire District Plan - 1st Alteration - Policy C31A.
