Officers recommended the above application for permission. However the Committee resolved to refuse the application for the following reasons:

- The proposal would result in the loss of existing playing fields, open space and recreational land and it has not been demonstrated that there is an excess of sports pitch provision and public open space in the immediate locality of the site contrary to West Wiltshire District Plan – First Alteration 2004 - Policy R2.
- 2. The proposal would result in the loss of an important visual gap between Shaw and Melksham that would be harmful to the rural amenity, character of the countryside and character of both settlements contrary to Policies C1 and H1 of the West Wiltshire District Plan 2004.

The proposed conversion of the existing dwelling would give rise to an unreasonable and over intensive sub-division of an inadequately sized property which is compounded by the inadequate provision of car parking and is therefore contrary to Policy H16 of the West Wiltshire District Plan First Alteration 2004.

Officers recommended the above application for permission. However the Committee resolved to refuse the application for the following reason:

The proposal would by reason of it design and relationship with surrounding properties have a detrimental impact on the amenity enjoyed by neighbouring residents contrary to Policy C38 of the West Wiltshire District Plan First Alteration 2004.
