Refusal as recommendation BUT delete reason 4 and re-number thereafter

Permission following S106 agreement as recommendation BUT the resolution to be modified in the last line to read after 'car park management plan 'to include 3 hours free parking together with parking/drop off space for the Zion Baptist Church'; and the conditions to be revised as follows:

Add extra condition after condition 8 to read as follows and re-number thereafter:

Extra condition 9:

The opening hours of the foodstore hereby permitted shall be limited to the hours of 0700 – 2300 hours Monday to Saturdays, and 0900 – 1800 hours on Sundays and Bank Holidays.

REASON: in order to safeguard the amenities of the area in which the development is located.

POLICY: West Wiltshire District Plan - First Alteration 2004 – Policy C38.

Condition 24 to be revised to add the following words after Church Street in the first sentence:

', together with signage to the town centre,'

Condition 27 to be revised to change the word 'with' in the final sentence to 'without'.

Application No. 3 – 08/00797/ADV - Sainsburys 29 Elms Cross Shopping Centre Rowden Lane Bradford On Avon

Split Decision as recommendation BUT add 1 condition to Part Consent as follows:

Condition 2:

The internally illuminated totem sign facing Moulton Drive shall be illuminated during opening hours of the store only and at no other time.

REASON: In the interests of residential amenity

POLICY: West Wiltshire District Plan 1st Alteration 2004 - Policy C38

Application No.4 – 08/00794/FUL - Sainsburys 29 Elms Cross Shopping Centre Rowden Lane Bradford On Avon

This application was deferred for negotiations to take place with the applicant to delete the 2 outside trolley bays closest to the highway.

Application No. 5 – 08/00393/FUL - Littlebrook Centre Bath Road Melksham Wiltshire

Application No. 6 – 07/03457/FUL - Fairlawns 398 The Spa Bowerhill Wiltshire

Permission as recommendation BUT Condition 9 to be revised to add the following wording after The whole scheme shall be subsequently retained before REASON ',

and the frontage beech hedge shall be maintained at a height of not less than 1.5 metres'.

Application No. 7 – 07/03864/OUTES - Land North East Of Green Lane Farm Green Lane Trowbridge Wiltshire

REFUSAL for the following 2 reasons:

- 1.The application is premature for the reason that the infrastructure, including the necessary highway network and education facilities, is not in place to support the development, nor is it likely to be secured by this development, contrary to policy H8C of the West Wiltshire District Plan 1st Alteration 2004.
- Notwithstanding the proposed vehicular access, the access for construction traffic through the existing development would be unacceptable and harmful to the amenity of existing residents by reason of nuisance and disturbance contrary to policy C38 of the West Wiltshire District Plan – 1st Alteration 2004.

Application No. 8 – 08/01142/FUL - Land East Of Innox Road Trowbridge Wiltshire

Permission as recommendation.

Application No. 9 – 08/00623/FUL - Land at Lower Westbury Road Bratton Wiltshire

REFUSAL for the following reasons:

1. The proposal, located remote from services, employment opportunities and being unlikely to be well served by public transport, is contrary to the key aims of Planning Policy Guidance Note 13 which seeks to reduce growth in the length and number of motorised journeys.

2. The traffic generated from the proposal would use a road, which by virtue of its function in the highway network and its inadequate width, alignment and junctions is considered unsuitable to accommodate the increase in traffic from this development and that for which it would set a precedent.

Application No. 10 - 08/00960/FUL - Land Rear Of 24 Sandridge Road Melksham Wiltshire

Permission as recommendation.

Application No. 11 – 08/00154/FUL - 13 Dark Lane North Steeple Ashton Wiltshire BA14 6EY

Permission as recommendation BUT add extra condition as follows: Condition 4:

The use hereby permitted shall enure for the benefit of the named applicant, Mr R Hodges, as an architectural studio for up to three employees for the period during which the premises are occupied by the applicant, and shall thereafter revert to ancillary residential use.
