Refusal for the following two reasons

- The proposal by reason of its overall design, density and layout would neither
 preserve nor enhance the character or appearance of the conservation area contrary
 to Policies C17 & C18 of the West Wiltshire District Plan 1st Alteration 2004, and
 would, furthermore, disrupt the character of Coronation Avenue and the surrounding
 area contrary to Policies H1 and H24 of the West Wiltshire District Plan 1st Alteration
 2004.
- 2. The proposal by reason of the restricted access and lack of visibility onto Coronation Avenue, together with the poor visibility at the intersection of the new access with the existing public footpath, would be prejudicial to highway safety and result in conflict between vehicular traffic entering the site and pedestrians using the public footpath contrary to Policy H1 of the West Wiltshire District Plan 1st Alteration 2004.

Application No.2 – 08/00496/FUL – Land North west of Dunkirk Business Park, Frome Road, Southwick.

Refusal as Recommendation.

Application No.3 – 08/03240/FUL - Land Adjoining 10 Ruskin Drive, Warminster, Wiltshire.

Permission as Recommendation.

Application No.4 – 08/03293/FUL - Land Adjoining 26 Melton Road, Trowbridge, Wiltshire.

Permission with the following 4 conditions

1. The development hereby permitted shall begin before the expiration of three years from the date of this permission.

REASON: In accordance with Section 91 of the Town & Country Planning Act 1990 as amended by Section 51 of the Planning & Compulsory Purchase Act 2004.

2. No development shall take place until samples of the materials to be used in the construction of the external surfaces of the development hereby permitted have been submitted to and approved in writing by the Local Planning Authority. Development shall be carried out in accordance with the approved details.

REASON: To ensure that the development harmonises with its setting.

POLICY: West Wiltshire District Plan - 1st Alteration 2004 - Policy C31A.

3. Before the development is occupied, the access drive and car parking spaces shall be surfaced in a bound material (not loose stone or gravel) to the satisfaction of the Local Planning Authority and shall be maintained as such thereafter.

REASON: In the interests of highway safety.

4. No development shall commence on site until full structural details and calculations are submitted to and approved in writing by the local planning authority to show the full extent of the retaining wall and parapet/fencing, including a typical cross section and details of the proposed retaining wall in relation to the footpath. The works shall be carried out strictly in accordance with the approved details.

REASON: To ensure the protection of the public highway and safety of pedestrians.

POLICY: West Wiltshire District Plan - 1st Alteration 2004 - Policy H1.
