1.0 Purpose of report

1.1 To seek Cabinet support for the regional improvement programme (Lift SW) attached as appendix B to this report

2.0 Background

- 2.1 A great deal of work has been undertaken by public sector organisations to raise standards across the whole South West region, hence the title of the document.
- 2.2 The draft document will be developed into an action plan in October 2006 and has already resulted in some £3.6M of resources being delegated from the National Improvement Board.
- 2.3 Work on the project is being co-ordinated by GOSW, which is asking local authorities, at member level, to confirm participation in the scheme. At the beginning of August 2006, two thirds of local authorities in the South West had done so.

3.0 Aims

- 3.1 Section 8 of the report sets out the aims of the document, to be achieved by March 2008. At appendix 1 of the document is a questionnaire on each council's ability to meet the targets set out in section 8.
- 3.2 A draft of the questionnaire has been completed and is set out in Appendix A to this report. As members will see (with the possible exception of the question on LGA Reputations), officers are confident that the targets can be met without any impact on resources, largely because the council already meets, or intends to meet, the challenges set out in section 8.
- 3.3 Officers are preparing a report on the LGA Reputations issue. Essentially, Reputations identifies a list of key services where research shows that good performance results in high levels of public approval, eg removal of abandoned vehicles and fly tipping. Initial work indicates that for the highest scores, increased investment would be needed, which the council may or may not be willing to fund. A caveat against this question is therefore included in the draft questionnaire.
