## 1. Purpose of report

**1.1** The purpose of this report is:

to describe the consultation process undertaken

to consider potential amendments to the offer; and

to recommend future action, including moving forward to the formal ballot if appropriate.

Under the provisions of Schedule 3A and 106A of the Housing Act 1985, the Council is required to consider representations made during the Stage 1 consultation and whether any changes should be made to the offer. The Council is also being asked whether to proceed to the formal Stage 2 of the Consultation process and whether to ballot the Council's secure and introductory tenants.

## 2. <u>Background</u>

- **2.1** At its meeting on 21 March 2005, the Council considered the report from the Head of Housing Management on Stock Option Appraisal. The Council resolved (minute no. 179) to support the proposal to consult tenants in respect of a large scale voluntary transfer of the Housing Stock.
- **2.2** Prior to commencement of formal consultation with stakeholders, it was necessary to promote the formation of South Wiltshire Homes Limited (as the prospective new landlord) and for South Wiltshire Homes Limited to adopt a number of key policies. At its meeting on 25 July 2006 the Stock Transfer Project Board considered the indicative valuation of the Council's Housing Stock prepared by Savills in conjunction with HQN and the final draft of the Formal (Stage 1) Consultation Document and resolved to proceed with consultation of the Council's tenants and leaseholders.

**2.3** The proposed transfer of council housing to South Wiltshire Homes Limited has been the subject of wide ranging consultation with council housing tenants and leaseholders. The purpose of the consultation has been threefold:-

To make tenants and leaseholders aware of the proposed transfer and provide opportunity to voice concerns, opinions and queries.

To gauge an expressed preference of tenants and leaseholders so that the Cabinet can decide whether to go ahead and formally ballot tenants.

To establish if there are terms of the proposal or offer document which should and can be amended either to clarify the proposal or make the proposal more acceptable

#### 3. Consultation

#### 3.1 Written responses

- **3.1.1** The formal consultation or Stage 1 offer document contained a tear off sheet which allowed tenants to express their view and express a preference for or against the proposed transfer. The Stage 1 offer document was posted on 30 August 2006 and tenants were allowed a period of 4 weeks ending on 29 September to provide comments.
- 3.1.2 The table below sets out the preferences of tenants as recorded in the tear off slips...

- **3.1.3** The views of the tenants ordered by "For", "Against", "Not Sure" are reproduced anonymously in Appendix 1.
- **3.1.4** A formal consultation document was also provided to the Council's Right to Buy leaseholders. This also contained a tear off sheet which allowed leaseholders to express their view and express a preference for or against the proposed transfer. The leaseholders' Stage 1 offer document was posted on 30 August and leaseholders were also allowed a period of 4 weeks (ending on 29 September) to provide comments
- 3.1.5 The table below sets out the preferences of leaseholders as recorded in the tear off slips

**3.1.6** The views of the leaseholders ordered by "For", "Against", "Not Sure" are reproduced anonymously in Appendix 2.

### 3.2 Meetings

- **3.2.1** All sheltered housing tenants were invited to meetings at their schemes to discuss the offer during this period
- **3.2.2** At all meetings a DVD explaining the Council's transfer proposals was shown, short presentations were made and an opportunity was given for questions to be asked.
- **3.2.3** In all 200 tenants attended the meetings. The Council's consultants have confirmed that this is representative of the experience of other local authorities.

#### 3.2.4 Tenants' independent advisor

- **3.2.5** Aldbourne Associates, the Tenants' Independent Advisors, who were appointed by the Tenants' Panel were present at all those meetings
- **3.2.6** A full report of Aldbourne Associates on the Stage 1 process is attached at Appendix 3.

#### 3.3 Leaseholders

**3.3.1** As set out in paragraph 2 above, all of the Council's RTB leaseholders have been written to and Appendix 2 sets out the results.

#### 3.4 Door step visits

- **3.4.1** From the 1 September staff from the Council's Housing Department started a programme of visiting all Council tenants' homes within the District. 60% of tenants households have been visited
- **3.4.2** The results of the survey up to the  $2^{nd}$  October are found in Appendix 4

#### 3.5 Other initiatives

- **3.5.1** A 13minute minute DVD has been produced and widely distributed to tenants, i.e. everyone has been offered a copy but were not forced to accept it.
- **3.5.2** The Council and Aldbourne Associates have each operated a Freephone telephone helpline throughout the consultation. The Council's helpline has received over 400 calls, mostly concerning arrangements for visits.

#### 4. <u>Summary</u>

- **4.1** The consultation process has been comprehensive. All tenants and leaseholders were sent the formal proposal documents and had the opportunity to return their written views (on a prepaid card). All tenants have been contacted and given the opportunity to discuss the proposal with a council officer.
- **4.2** The Council can be confident that every reasonable opportunity has been given to tenants and leaseholders to express their views and fully understand the basis of the proposed transfer
- **4.3** The preferences expressed in written responses are statistically close to those received on the doorstep visits. What cannot be confidently predicted is how many tenants will vote in postal ballot.

- **4.4** Members will see that from our results there is a majority of tenants who have expressed a view in favour of the proposed transfer.
- **4.5** The comments that are listed in the Appendices have no indicative theme which would indicate any requirement to change the proposed offer as set out in the formal (Stage 1) consultation document.

#### 5. <u>Conclusion</u>

- **5.1** The Council has now carried out detailed and meaningful consultation with the tenants and leaseholders in respect of large scale voluntary transfer to South Wiltshire Homes. Whilst indicative figures need to be viewed with caution it would appear that there is significant support from tenants for transfer
- **5.2** It is now proposed that the Council commissions Electoral Reform Ballot Services Ltd (part of the Electoral Reform Society) to carry out a formal postal ballot of all secure and introductory tenants and that the offer to tenants and leaseholders be confirmed.

#### 6. <u>Recommendations</u>

It is recommended that:

- **6.1** the responses of tenants and leaseholders (as set out in this report) be noted.
- **6.2** a formal Stage 2 letter be issued to the Council's secure and introductory tenants confirming:
  - 6.2.1 the terms of the Council's offer as set out in the formal (stage 1) consultation document
  - 6.2.2 Tenants' right to communicate objections to the Council's proposals to the Secretary of State within 28 days from the Stage 2 Letter.
  - 6.2.3 the ability of the Secretary of State to withhold consent if a majority of affected tenants do not wish the transfer to proceed.
- **6.3** Electoral Reform Ballot Services Limited be commissioned to carry out a formal ballot of tenants in respect of a transfer to South Wiltshire Homes.

### 1. INTRODUCTION

Aldbourne Associates were appointed as Independent Advisers to Salisbury District Council tenants and leaseholders throughout the consultation process to ensure that they have all the advice, support and information they require in order to make a decision on the transfer proposals.

This has involved:

- holding meetings with members of the Tenants' Steering Group and at regular intervals throughout, and meetings with the Tenants' Panel as required. These meetings concentrated on obtaining tenants' views on the various documents, in particular the Formal Consultation Document and offer to tenants and the proposed tenancy agreement
- attending regular meetings of the Stock Transfer Project Board to support tenant representatives
- regular meetings and liaison with the Council team and their consultants to ensure tenants views were fully represented during the development of the transfer proposals
- commenting on Council documents
- attending a Tenants' Conference to provide information on the transfer process and encouraging more tenants and leaseholders to get involved
- providing newsletters updating tenants throughout the process, which were distributed to every Council home
- making available a freephone number for tenants and leaseholders to contact us for independent advice and information
- providing a specific page on our website with information for Salisbury tenants and an email link for enquiries
- attending drop in sessions around the district to answer questions and provide information
- visiting each sheltered scheme within the district twice, to provide information and answer questions
- a home visiting service for tenants where they were unable to attend sessions.

This report contains the findings of our work with tenants in Salisbury which the Council needs to be aware of when considering whether to progress to the ballot stage.

### 2. ACKNOWLEDGEMENTS

Many people have been involved in helping us to do our job as Independent Advisers during the consultation period.

Our thanks go to the following:

- the Council's project team who have assisted with information and who have worked with us, the Steering Group, the Tenants' Panel and the Leaseholders' Forum
- the Tenant Participation Team at the Council who assisted with arrangements for meetings and have helped develop the Steering Group
- the Stock Transfer Project Board which included a representative from the Tenants' Panel
- members of the Shadow Board of South Wiltshire Homes who have attended Steering Group meetings to provide a direct link to the Board

A very big thank you also goes to the members of the Steering Group and Tenants' Panel who have committed themselves to many long hours of meetings, getting to grips with the issues and the detail, negotiating on behalf of tenants and leaseholders and making sure that everyone would receive documents that could be easily understood.

### 3. OUR MAIN FINDINGS FROM THE CONSULTATION

An analysis of the issues raised by tenants on the freephone is given in the appendices. Issues raised at the sheltered scheme meeting and home visits were similar to those raised via the freephone. It should, however, be stressed that due to practical difficulties in recording every point raised this list is not necessarily exhaustive.

#### **TENANTS PRIORITIES**

Using information gathered from the Tenants' Panel and Steering Group and the aspirational survey carried out in Autumn 2004, we undertook a survey of tenants priorities for improvements. Tenants were asked to rate a number of improvements in order of importance. Kitchens and bathrooms emerged as most important, followed by windows and doors and then fencing and gates, Full details of the survey can be found in Appendix One.

#### **PROVISION OF INFORMATION**

The Council have endeavoured to make information accessible and understandable to tenants through fact sheets, a question and answer booklet, the formal consultation document, newsletters, and a video/DVD.

On the whole, the final version of the Formal Consultation Document and the proposed tenancy agreement were felt to be very well presented and readily understandable by the Tenants' Panel and Steering Group. These documents also generally seem to have been well understood by tenants across the Salisbury District.

The video/dvd also appeared to be very well received by sheltered housing tenants and it was considered that the message was expressed clearly in this format.

In addition, Council officers are visiting every council home and talking to individual tenants about the proposals, giving out videos/dvds and answering questions. Tenants have told us that they have found the home visits helpful and informative and they have generally welcomed the contact with housing staff.

#### SHELTERED SCHEME MEETINGS

The Council and Aldbourne visited all 22 sheltered schemes around the district with 200 sheltered tenants attending meetings and a further 115 being spoken to on the doorstep or in their homes. The remaining 228 sheltered tenants were left a card and a copy of the dvd.

#### **ISSUES ARISING**

Questions about the proposals have been wide-ranging and have shown that secure tenants have a good grasp of the issues surrounding the proposed transfer.

Although the number of calls to our freephone were relatively low, tenants told us that they have found the information from the Council comprehensive and that many of their questions have had been answered by Council staff carrying out home visits. Details of the freeophone calls can be found in Appendix Two

We have not come across any new issues or real concerns that would lead us to suggest that the proposals need to be amended or added to.

#### FURTHER CONSULTATION

The Council and Aldbourne are holding a series of drop in sessions for general needs tenants around the district. This consultation will run from 5<sup>th</sup> October to 19<sup>th</sup> October. Issues arising from this consultation will be reported separately.

### 4. CONCLUSIONS

Our programme of work with the tenants of Salisbury District Council lead us to conclude that they have been given sufficient information to assess the proposals for the transfer of the Council's homes to South Wiltshire Homes.

The majority of people that we met and spoke to on our freephone did demonstrate a reasonable grasp of the proposals and the issues surrounding transfer.

We can therefore be reasonably confident that the majority of tenants have had sufficient time and information to consider the advantages and disadvantages of potential transfer.
