### 1 Purpose:

To consider arrangements for corporate items arising from the closure of the Bourne Hill offices.

### 2 Background:

In the last few months service units have moved from Bourne Hill in preparation for the potential redevelopment of the site under the Office Centralisation Project.

Although service units have taken the majority of their equipment and furniture with them, there are also a number of corporate items (particularly relatively high value items such as pictures, clocks and furniture), which require special treatment.

With the full closure of Bourne Hill, the officers have undertaken an inventory of the items, sought valuations where appropriate, and arranged short-term storage. A list of the items including valuations and destinations is attached as *Annex A* to this report.

In summary, with some exceptions, these items are to be kept in the Council's ownership pending a decision on their long-term future when the refurbishment of Bourne Hill is nearing completion.

The Cabinet is asked to note the arrangements made and to authorise the officers to enter into detailed negotiations for the disposal of a limited number of items if it is considered appropriate.

## 3 Proposed Arrangements:

As shown in Annex 1 the majority of items will be stored in Council owned accommodations, particularly the Guildhall. This is considered to be appropriate for the following reasons:

- The storage is high grade and suitable for items being housed.
- The items would remain under the control of the Council and risks would be minimised.
- The use of the Guildhall allows increased access for the public enjoyment of the assets, particularly pictures, silverware and clocks.

- It was not considered appropriate to dispose of the items due to:
- Questions over the legal title to some items. Many items came to be held by the Council following the transfer of assets from predecessor bodies. It is not always possible to ascertain how the items came into the possession of those bodies given the time that has elapsed.
- The Council's long-term requirements for the items have yet to be determined. At the time of writing the use of the ground floor of the original house by Wiltshire County Council's Registrar's Department is subject to continuing negotiations. Therefore it is not possible to identify which of the present items may or may not be required when the proposed redevelopment is completed.

In addition, some items have been loaned to appropriate organisations eg the Bust of Richard Jefferies, the clock from the Cabinet Room and the table from Committee Room 2. These items will remain in the Council's ownership.

#### 4 Items for Possible Disposal

Although it is considered appropriate to retain most of the items pending a further review once the requirements for the refurbished building becomes clearer, the Cabinet may wish to consider the following requests which have been received:

#### 1 The Edwin Young Pictures

The Curator of the Edwin Young Collection has contacted the Council with regard to future of 6 pictures by the Artist, which were housed in Committee Room 1. The Curator believes that these paintings formed part of the original bequest in 1912 although he is not certain.

The Edwin Young Collection is held in Trust (with Wiltshire County Council being the sole trustee) and is housed at the Salisbury Library.

As can be seen from Annex 1 the pictures do not have a high financial value.

The officers consider that it would be appropriate to enter into negotiations with the Trust over the future of the paintings as it would be beneficial for their preservation and provide access to a wider audience. It may also be possible, as part of any agreement, for other items within the Collection to loaned to the Council on a temporary basis to be exhibited in the new offices.

#### 2 The City Chairs

The Clerk to the Charter Trustees has contacted the Council with regard to 43 "City" chairs.

The chairs form part of a collection of over 100 bearing the "City" crest. In 2003 the Council transferred the ownership of 60 of the chairs, which were housed at the Guildhall, to the Charter Trustees under a covenant that the chairs would be restored and be retained for use in that building.

The Clerk considers that it would be prudent for the chairs to be reunited in the Guildhall and he is sure that in the future The Charter Trustees would look to refurbishing them as well.

The Council's Valuers did not consider that the chairs were of significant financial value although bringing the assets together would increase their overall value substantially.

The Cabinet is asked to consider the request from the Charter Trustees.

#### 5 Recommendations:

- 1 that the arrangements for the storage of the corporate items be noted;
- 2 that the requests received for the disposal of those items listed in Section 4 of the report be determined, in principle;
- 3 that the officers be authorised to enter into detailed negotiations for the disposal of any items agreed in principle under (2) above; and
- 4 that a further report on the future retention and disposal of high value items be brought before the Cabinet prior to the reoccupation of Bourne Hill.
