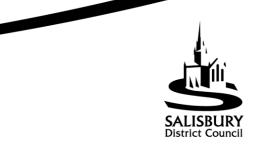

### 18 (a) Tisbury and District Sports Centre Internal Work Costings:

Cabinet Minute 127 resolved that Officers produce an outline costing report for the Cabinet's budget meeting on 30 January regarding improvements to the internal layout at Tisbury Sports Centre that would both enhance the front entrance and address disability access issues. A revised internal layout has been produced and provisional costs associated with the work are estimated to be in the region of £65,000, with the caveat that there may be unforeseen costs that come to light once work has commenced.

In line with best practice the Council has a rolling capital programme to finance work of this nature with priorities for funding assessed against the criteria set out in the Capital Strategy. The capital programme has a five year period and is routinely re-assessed and profiled during the financial year, subject to Cabinet and Full Council approval.

In order to ensure that requests of this nature are not considered in isolation it is recommended that once Cabinet has approved both the Revenue and Capital budget for the forthcoming year, members review the approved capital programme during the year to determine whether it should be revised to accommodate this work, in line with the Capital Strategy.
