1. Report Summary:

- 1.1 This information included in this report and accompanying papers is intended to inform the Committee of a participatory budgeting initiative approved by Salisbury Area Board as part of its development phase.
- 1.2 It is intended that the report will provide the information necessary for the Committee to be able to release the sum of £30k as the pot of money used to fund community projects identified through the participatory budgeting process.

2. Background:

- 2.1 Salisbury City is one of twelve community areas chosen to pilot Area Boards and test aspects of local governance as part of, and in readiness for the transition to a Unitary Authority.
- 2.2 Wiltshire is committed to engaging with the process of Participatory Budgeting (PB) through the development phase of its Area Boards and Salisbury was identified as one of two areas, along with Calne, to pilot this initiative. The purpose of this initiative is to test and evaluate the process of PB in Salisbury with the intention of developing a broader programme rolling out PB across all community areas in Wiltshire.
- 2.3 In order to ensure the initiative is managed well, the project has enlisted the help and support of The Participatory Budgeting Unit (PBU), a charity partially funded by Communities and Local Government to support the implementation of PB in England.

The PBU defines PB as:

'Participatory Budgeting is a method where local people decide how to allocate part of a public budget. It directly involves local people in making decisions on the spending and priorities for a defined public budget and aims to increase transparency, accountability, understanding and social inclusion in local government affairs.'









The government hopes that all local authority areas will be using PB by 2012.

3. The Project

- 3.1 Following the decision to undertake PB in Salisbury, the Chair Cllr Paul Clegg and Project Manager, Marianna Dodd attended a PBU conference which outlined good practice elsewhere in the country. Feedback to the Salisbury Area Board led to a decision to enlist the support of a consultant adviser to the PBU, Leslie Silverlock, Local Improvement and Neighbourhood Renewal Adviser whose first task was to give a presentation to members and provide guidance on PB methodology, including its values, principles and standards. Leslie has been very impressed by the commitment of the Salisbury Area Board and steering group to make PB happen, communicating this back to the PBU and at the PB Conference at Taunton. (Appendix 1)
- 3.2 As the Salisbury Area Board had chosen young people as its target group for testing aspects of local governance, a decision was made to adopt 'young people engaging with disabilities' as its target group for the PB initiative. This was supported by the PB steering group.
- 3.3 A steering group for PB has been established which is primarily made up of stakeholders committed to the delivery of services to young people including those involved in setting up the Youth Council in Salisbury. Every effort is being made to make the appropriate links to ensure we build on best practice and expertise already being delivered in the Youth Development Services and to build sustainability into the project. For instance, youth development workers working within the PB project will also be gaining insight into how best to engage young people in the Salisbury Area Board post July, 2009, from looking at how meetings are organised to how they will participate in public meetings.
- 3.4 The steering group has met on a number of occasions to agree a project plan and timescale for delivery. (**Appendix 2**). A PB event has been planned for the 21 March, 2009.
- 3.5 The benefits to undertaking PB, in respect of this project and target group, include:
 - supporting the 'duty to involve' enabling Wiltshire Council to comply
 with the provisions of the Local Government and Public Involvement in Health Act 2007 in
 providing a process of citizen engagement.
 - involving the target group of young people and associated citizens, stakeholders, councillors, public sector representatives and local government officers working together toward a joint aim
 - increasing the voice of the target group of young people in local decision making
 - focusing on young people, the project will be including a group of people not traditionally engaged in budget and policy decisions
- 3.6 Local authorities are to be able to devolve up to 5% of their budget for youth service to young people's influence in 2010 and 2011. The government's long term aspiration is that, by 2018, young people could actively shape decisions on 25% of local authorities' budgets for positive activities. Testing the process of PB should provide an insight into how this works in practice as young people will be invited to demonstrate, through presentations, their views and aspirations for community projects, chosen by them and funded through Salisbury District Council.

Cllr Paul Clegg, supported by members of the Salisbury Area Board, initiated the request for £30k from Salisbury District Council, as the pot of money to be used for community projects which would be identified by young people involved in the PB project. The £30k will be split between x number of separate pots, a decision to be made by the steering group. The £30k will be administered through the offices of Niki Lewis, Service Director for Community Leadership and Governance at Wiltshire Council and ring-fenced for Salisbury Area Board's participatory budgeting project.

It has been agreed that operational funding for the PB project will be met by Wiltshire County Council.

3.7 Success criteria for the project will include:

Involve and engage Area Board members in PB initiative

Empower relevant local groups and organisations to bid for money

Resident participation in decision making

Establish processes and accountability lines that are clear, concise and productive

Aim to meet citizen's & young people's quality expectations

Pilot Area Board agree & support initiative

Members sit on Steering Group

4. Consultation undertaken

In this respect, and due to the short timeframe of the project, the steering group has agreed that the project will draw on information collated, i.e., through reviews of young people's views of their needs in the Young People's Plan.

Context

Wiltshire is committed to PB and has identified Calne and Salisbury as pilots. The County is to become a Unitary Authority with Area Boards; Salisbury will also have a Parish Council. These are potentially radical changes, seen to be presenting a number of opportunities and threats.

Preparation

Marianna Dodd, the Area Board Manager, has prepared key decision makers well, to a state of readiness, and secured the promise of a budget. There is also a Steering Group of other partners and advisers. The new Board's Chair was inspired by the PB Conference.

The Salisbury Area Board is constituted of elected members, Police, Fire & Rescue, Health, Education and supported by WCC CE Keith Robinson and Carolyn Hamblett, Director of Children & Families

The Focus of the PB Project

will be the empowerment of young people. Decisions are currently being made about whether to focus on

- All young people across the City
- A specific target group of young people e.g. at risk; housebound carers
- A neighbourhood group in a residential area

Links

are being made with the Children and Young People's Plan, the Community Plan / LAA, Youth Opportunities Fund, Planning Section 106.

Some next steps include

- 1. Securing budgets
- 2. Identifying the target group
- 3. Set performance criteria
- 4. Form a planning group of young people
- 5. Conduct risk assessments
- 6. Put monitoring template in place

Limitations

Marianna Dodd, who is driving the programme thoroughly, has the management and facilitation of all the Area Board's work to co-ordinate, as well as piloting this PB Project.

Advantages

Strong political balance and commitment. They are already looking at a bigger budget for the next financial year. The REIP is likely to be interested.
