1	<p>Suggested adding local crime and disorder partnership as a consultee.</p> <p>Commented on display of materials - which is already covered by conditions.</p>
2	<p>Signed petition - no further comments attached.</p>
3	<p>Voiced concerns re effects on women and questioned why churches are included as inappropriate proximity.</p>
4	<p>Suggested amendments to consultees and suggested distance between establishments be extended to 20 miles.</p> <p>Raised issue on moral grounds not being considered.</p>
5	<p>Fully supports draft policy.</p>
6	<p>Suggested Licensing Committee consider all applications.</p>
7	<p>Clarification on 'market' and 'at risk' definitions and commented on six monthly review and distance guidance.</p>
8	<p>Suggested consulting with church organisations and wider consultation.</p> <p>Suggested limit number of sex shops either 0 or 1.</p> <p>Suggestion increasing distance and granting any initial licence for six months only.</p>
9	<p>Recommending zero limit on sex shops in Trowbridge, and concerns about effect on the character of the area.</p>
10	<p>Suggested widening consultation process, and potential limit on numbers.</p> <p>Recommended that reference is made to the character of the area.</p> <p>Suggested adding to list of inappropriate proximity routes used regularly by under 18's.</p>
11	<p>Supported draft policy - sensible and measured.</p>
12	<p>Suggested inclusion of Social Services as consultees and add areas where residential homes and people with learning difficulties to inappropriate proximity list.</p>
13	<p>Unanimously agreed draft policy and sought clarification of the six miles limit.</p>

14	<p>Requested that nursery schools be added to inappropriate proximity list.</p> <p>Suggested that a radius of six miles is used.</p>
15	<p>Suggested an increase of the distance within inappropriate proximity to at least 500 metres and define how distance is to be measured.</p> <p>Suggested all applications to go to Licensing Committee.</p>
16	<p>Suggested an increase of the distance within inappropriate proximity to at least 500 metres and define how distance is to be measured.</p> <p>Suggested all applications to go to Licensing Committee.</p> <p>Suggested adding children's playgrounds to inappropriate proximity list.</p>
