Our project will provide people in the local community with better chances in life by giving them the opportunity to try out new sporting activities within a safe friendly environment. In turn this can lead to them leading healthier lives. Our project is focused on providing sporting opportunities to the community and specific targeted groups that are prone to none participation. It is also hoped that by offering these opportunities it will provide the community with confidence and encourage them to volunteer within local sports club. Taken from the 2001 census we are aiming towards 38% of the local population and we achieve in getting half of them active that is an additional 6,000 people leading an active healthy life. Our population is predominately white British (95%) but we would ensure that we are not discriminating against any black and ethnic minorities within the community.

This project is part of a larger project that will see the construction of an Air Dome on Chippenham Sports Club. The grant we are requesting is for start up costs for equipment, all the other costs have been incorporated into the business plan for the Air Dome so all other costs will be met by charging for use of the facility.

The need for the Air Dome was initially identified by Netball who currently have no indoor training facilities. Since the initial meetings with Netball the Sports Club have began to understand the needs of the community via the lack of facilities on offer. The existing leisure centre and schools are full to capacity at peak times and can provide a daunting experience to those new to sport. Our facility is focused on a friendly environment which is open to all no matter what their circumstances. Through discussions with local groups/members of the community we have realized that there are many people who would like to become active but have constraints that stop them. The main barriers to participation are money and time. We aim to keep the cost for certain groups to a minimum and offer the sessions when they require them. The project is financially based on making enough money to run the facility through evening bookings like Netball and 5-a-side football. This in turn leaves the day time slots free for sessions that involve older people, young mums and their children and schools. The project does support Wiltshire Council's and Sport England's objective of increasing participation in adults and children. We will know the facility is making a difference by the popularity of the facility. The community has stated there is a need for such a facility and we hope that by providing it and the sessions that they require it will help people lead a more active and healthier life.
