I run two open youth groups, one called Kool Kidz which runs on a Wednesday night at Sheldon Road Methodist Church and has membership of 15 young people aged between 11-14years old. There is an equal mix of males and females in the group. The young people come from disadvantaged backgrounds and would normally be hanging out on the streets at night. They all live in the immediate area of Sheldon Road Methodist Church and attend the local secondary schools. The other group is called Ichthus which runs at Central Methodist Church on a Thursday evening and also has a membership of 15 young people aged between 11-18years old. The young people come from all around Chippenham with different backgrounds, some more disadvantaged than others. The group is primarily females which is something we are looking to change and encourage more young males to join. All but two of the young people go to the local secondary school. Both clubs enjoy cooking, craft, trips and many more activities which are enjoyable while giving them an opportunity to be informally aware of social and interpersonal skills.

I will be looking to other sources for financial help over the course of the next accademic year once any given money has been used.

We empower the young people of both youth clubs to prepare their own programme of weekly events. However their creativity in what they want to do is currently restricted due to lack of funding. We charge minimal amount at Ichthus to encourage equality for all members but this has a knock on effect with funds being available for activities. There is no charge for Kool Kidz as this would put a restriction onto who would be able to come which has a greater knock on effect on the possibilities. With the award the young people will be able to explore more avenues to new and different activities which will give opportunity to express themselves in different ways. It will also bring the opportunity for the young people to use their gifts as we would be able to invest in more materials for them to use in things such as craft and cooking.
