We have a small fund (about £200) available to get started and envisage that the other running costs will be generated from voluntary contributions from the beneficiaries

In order to reduce costs, we will be sharing the use of the camera with Westlea Housing Association, who will be using it to check the thermal insulation of their housing stock. CAVE has identified 2 local areas, Kington St Michael village and Birch Grove in Chippenham, where we have volunteers who will run pilot schemes to perfect operational procedures before offering the service throughout the area.
