1. PURPOSE OF THIS REPORT

The purpose of this document is to highlight the progress made on the actions in the Salisbury City Community Plan.

2. BACKGROUND

During the summer of 2003, the South Wiltshire Strategic Alliance distributed a community questionnaire to 49,000 households in South Wiltshire, of which 6,413 were returned from Salisbury. The results of the questionnaires, coupled with public meetings and City Workshops, identified a number of priorities across the City Community Area. These were, in order of priority:

- 1. Vandalism and Anti-Social Behaviour
- 2. Reducing Crime
- 3. Traffic Congestion
- 4. Cleanliness of Roads, Streets and Open Spaces
- 5. Better Healthcare
- 6. Looking after the Roads
- 7. Housing Local People Can Afford
- 8. The Environment

The priorities identified have been allocated into 8 themes, which reflect the policy themes in the Wiltshire Community Strategy. These themes are: Countryside and Land-Based Issues, Crime and Community Protection, Culture, The Economy, Education, Skills & Learning, Housing and The Built Environment, Social Care and Health and Transport.

The draft City plan was subjected to extensive consultation with key stakeholders and the City Area Committee in 2004. The final draft was approved by the City Area Committee on 5th October 2004 and was published in January 2005. The plan covers a five year period, 2004-2009. The purpose of the plan is to publish the results of what local people want to see, as well as influencing partner organisations of South Wiltshire Strategic Alliance to address priorities in the City area.

3. MONITORING THE PLANS

It has been agreed that the Alliance will provide six-monthly monitoring reports for all six Community Plans. It is worth noting that the City Community Area has been without a Community Planner since January 2005, making it difficult in some instances to obtain information against actions.
