Debbie Dixon, Policy Director of Salisbury District Council, speaking as the applicant and Andrew Burgess of Turley Associates, Planning Consultant for the proposal, spoke in support of the above application.

Further to these statements and the site visit held earlier that afternoon, the Committee considered the previously circulated report of the Head of Development Services together with the schedule of late correspondence circulated at the meeting.

Recommended to the Planning and Regulatory Panel:

that the above application be refused for the following reasons:

- The proposal as submitted would lead to the loss of green space and trees, which collectively form part of an important element of the urban open space network within the Salisbury Central Area. As such the proposal is contrary to policy D5 of the adopted Salisbury District Local Plan in that it does not enhance further the provision or use of such space.
- 2. The proposal that includes the stopping up of the entrance to the eastern access of the College Street car park will result in congestion and an increase in the volume of traffic upon the surrounding road network, loss of residents on street car parking and insufficient car parking for visitors to the proposed extended offices. As such the proposal is contrary to policy G2 (ii) of the adopted Salisbury District Local Plan
- 3. The proposal to extend the existing council offices, a Grade II* Listed Building, is not considered to be appropriate in terms of its scale design and materials. As such the proposal is contrary to policies CN3(i) CN5 of the adopted Salisbury District Local Plan and guidance in PPG15 in particular Annex C, paragraph C7.

382. S/2006/0201: Listed Building Consent at Bourne Hill Offices, Salisbury SP1 3UZ for Salisbury District Council:

As such the proposal is contrary to policies CN3(i) CN5 of the adopted Salisbury District Local Plan and guidance in PPG15 in particular Annex C, paragraph C7.
