Provides an activity for Young People and helps some people to lose weight and lower the likelihood of heart disease and other obesity related problems. For the children it makes taking exercise enjoyable and, one hopes, encourages healthy living for the future. We have built up a membership of 90 and young and older people train to be able to run a mile and then run this distance each week (for the children's group we often do a game or training exercise that involves running a mile but makes it more fun). The membership includes children and older people of both sexes. Approximately 35 people run each week ( Please note that 14 months ago we averaged 15 each week) and we give certificates for 10 (bronze), 20 (silver) and 30 (gold) miles. At 50 miles members get another certificate and a special T-shirt. North Wiltshire District Council supported this enterprise and gave us an initial supply of certificates. I am applying for funds to buy card, printer ink and A4 laminating pouches.

A grant of a few hundred pounds would last a considerable time. Eventually a subscription might be necessary but I am loathe to charge one as I don't want to exclude anybody e.g. because parents are unwilling or unable to pay.

There are many people for whom running a mile is a real challenge. This Club enables people to get fit in a friendly supportive group and I try to vary the activity so as to maintain interest e.g. small prizes, different routes, a relay or game. The laminated certificates mean a huge amount to the children (and many of the adults) and they are very proud of them. Aiming for the next certificate definitely gives an incentive to keep attending with the resulting improvement in physical fitness. Some people, who lacked confidence at first, are now good runners.
