The project will benefit all young cricketers in the area, but particularly female ones. As a Club we currently run 6 junior sides of which 2 are girls teams (U13 & U15) and the other 4 mainly boys, but with girls often forming a small proportion of the team. As a Club we are fully committed to equality within sport and to the promotion of girls cricket and we are anxious to ensure our girls have equal facilities to the boys. Currently on mixed training nights (3 times a week) and in 'boys' fixtures where girls form part of the team we cannot offer the females their own changing facility - they must come changed or use the female WC's. Our project involves the demolition of an existing lean-to shed adjacent to our pavilion and the re-building of a female changing room complete with shower and new shed in the same area. The footprint of the new construction is only about 4m² larger than the existing shed so planning permission is not required. This will definitely improve our facilities for our girls and definitely attract new members.

We currently have 35 female members, all of whom have to use our female WC for changing when playing mixed games or training. This is unacceptable. Being able to offer separate changing facilities is not only fair and equitable but will undoubtedly help us attract more female members between the ages of 9-16.
