## CHAIRMAN OF THE COUNCIL - COUNCILLOR MRS SPENCER - IN THE CHAIR

**1. Prayer -** Reverend Chris Moorsom, Rector to Upper Stour Parish, opened the proceedings with prayer.

#### 2. Outgoing Chairman's Report:

Prior to the formal business of the Council the outgoing Chairman addressed the meeting, highlighting some of the main achievements of the Council throughout her year as Chairman, as set out below. The Chairman also congratulated all Members on their election, 16 of whom were completely new to the Council, a further 5 had returned after a period of absence.

- The opening of the fourth park and ride site at London Road in July 2006, with the council's 1,000,000<sup>th</sup> park and ride customer anticipated during 2007.
- The successful completion of the planning process for the complex planning application relating to the Stonehenge Visitors Centre.
- Securing 151 affordable homes during 2006/07 and receiving grant allocation of £7.1m (the highest grant allocation in Wiltshire) to build 300 homes over the coming two years.









- Salisbury's Tourist Information Centre receiving the accolade of best TIC and best customer service by South West Tourism.
- The launch of a public consultation exercise asking how Salisbury's residents want to use the city's precious open spaces.
- Further successes in the Britain in Bloom awards.
- Continuing work on the vision for Salisbury, culminating in a master plan for guiding change and development over the coming decades, including a published set of proposals containing 24 potential improvements to the city for those who work, live and shop in it.
- Continuing improvements to the council's website, resulting in the council performing amongst the best in the country in a recent national survey.
- Hosting a housing workshop in January 2007 called "A Place to Call Home". The workshop was a huge success with hundreds of people dropping in for advice.
- Scoring amongst the top performing councils in the country in a residents' satisfaction survey, with the council's rate increasing by 5% to 68%. Similarly, a survey of council house tenants revealed 82% satisfaction with the overall service received.
- The City Hall's Preview Guide winning a national award for its quality of information, format and clarity of design.

The Chairman added that it had been an honour and privilege to hold the position, for which she was deeply appreciative for the opportunity. The Chairman had attended numerous facilities and events throughout the year, including various community activities; charity fund-raising days; youth, sports, music and arts events; schools; nursery schools; youth groups and facilities for the elderly and disabled throughout the district, together with civic services, awards presentations, receptions and royal visits.

Further to this, the Chairman paid particular congratulations to the Salisbury City Football Club for their recent success and promotion to the Conference League. The Chairman then went on to thank all those working throughout the district, both volunteers and others, who continue to give of their time and energies to enrich the lives of others in the community. Thanks were given to council staff for their dedication, hard work and notable achievements throughout a most challenging year, with special thanks dedicated to Mrs Jo King, Personal Assistant to the Chairman throughout the year, and Councillor Kevin Wren for his backing as Vice - Chairman. In addition, the Chairman thanked members of all council groups for their support and encouragement during the year, and particularly to the Chairman's husband and family for their constant support and particularly for the provision of musical entertainment at the Chairman's end of year reception at Stourhead.

The Chairman asked those present to join her in remembering with sadness, affection and gratitude, Margaret Peach, ward councillor for Downton; and Catherine Walsh, wife of Councillor John Walsh and much loved local teacher: both of whom passed away in 2006.

The Chairman also expressed her best wishes to former Councillor Mr A P Peach, who had recently had to go back into hospital.

Tributes were paid to the outgoing Chairman.

The Chairman informed councillors that concerns from another Member had been brought to her attention regarding the council's ICT policy for officers and Members, the terms of which stipulated that the use of external email accounts were not allowed. The Chairman explained that, pending reconsideration of the policy, the council would not seek to impose this requirement in the policy on Members as it would currently inhibit them from being able to perform their Councillor role.

The Chairman also reported that concerns had been communicated by another Member in relation to the government's proposals to close Post Offices on a national scale, and that she hoped the council's new Leader would address this matter later in the meeting.

Finally, all councillors and officers were warmly invited to join the Chairman for a drink in the bar after the meeting that evening.

#### Annex C

Statement by the Head of Financial Services and Head of Legal and Property Services

If Council choose to support this motion, we must draw your attention to the following. In accordance with the Full Council decision in December 2006 the Council is in contract with Bluestone to carry out the construction of the new offices in accordance with the agreed design and timetable.

Whilst construction on site can be put on hold pending the special cabinet meeting, it must be understood that Bluestone will continue to mobilise resources within the terms of their contract. These activities will incur significant amounts of contractual liability. Whilst not quantifiable in exact terms the amounts will be of material financial consideration should a subsequent Full Council wish to end the existing contract.
