(a) Consideration of Scrutiny Committee Recommendations

The Scrutiny Committee had resolved to call in the decision of Cabinet dated 5 April 2006 concerning the Council owned development sites for the Housing PFI Scheme. It considered the matter in detail at its meeting on 17 May when it made the following recommendation to Council:

To refer consideration of the matter to Council to note and debate. To report that the Scrutiny Committee was unhappy with the merits of the Cabinet decision. The Committee believes that potentially there may have been maladministration and/or unlawfulness . The Committee considered that this was the only mechanism to bring it to the Council's attention.

The Scrutiny Committee had also made a number of recommendations to Cabinet.

(b) Commitment to Proceed with the Housing PFI Scheme

Cllr Carbin presented a report, which gave Council the opportunity of reaffirming its commitment to proceed with the Housing Private Finance Initiative (PFI) and to invite guidance to Cabinet on the implementation of the Policy Framework.

The Housing PFI Project Manager gave a presentation on the key points of the scheme and what had changed since the 19 July 2005 Council meeting. At the request of the Chairman, he responded to the points raised during the open forum session.

 - That all planning applications in respect of the PFI scheme be determined by the Planning Committee and not delegated to officers.
 - Request Cabinet to carefully consider community concerns and wider issues.
 - That Cabinet should not dispose of land from the list of agreed sites following refusal of planning permission for such sites for the PFI scheme.
 - That Cabinet should work in full consultation with Town and Parish Councils before disposal of land.
 - That Cabinet uses its best endeavours to avoid inclusion of sites identified as being sensitive.
 - That Cabinet be requested to seek alternative land as a matter of priority.
 - That Cabinet be requested to reconsider its decision dated 5 April 2006 having regard to the above comments.
