Annual Report of the Standards Committee

November 2006

Introduction

I am delighted to have the opportunity to introduce this second report by the West Wiltshire Standards Committee.

The Committee was formed in 2001 as a consequence of the Local Government Act 2000. Its membership comprises four District Councillors (representing the main party groups) a Parish Councillor, a Town Councillor and three independent (ie non elected) members. The Chairman and Vice Chairman are selected from the independent members.

The body of this report provides details of the roles and function of the committee. I think the essence of what we are trying to achieve can be summarised as "being proactive in helping to create and maintain the highest ethical standards throughout the District, Town and Parish Councils in West Wiltshire.

The Standards Committee

The Standards Committee is composed of 4 District Councillors and 5 independent members including Town Council and Parish Council representatives. It is concerned with promoting and maintaining high standards of conduct by all parish, town and district councillors in West Wiltshire.

What is the Standards Committee's Role and Function?

- (a) promoting and maintaining high standards of conduct by Councillors and co-opted members;
- (b) assisting the Councillors and co-opted members to observe the Members' Code of Conduct and any local Protocols;
- (c) advising the Council on the adoption or revision of the Members' Code of Conduct and of any local Protocols;
- (d) monitoring the operation of the Members' Code of Conduct and any local Protocols;
- (e) advising, training or arranging to train Councillors and co-opted members on matters relating to the Members' Code of Conduct and any local Protocols;
- (f) granting dispensations to Councillors and co-opted members from requirements relating to interests set out in the Members' Code of

Conduct and any local Protocols;

- (g) dealing with any reports from a case tribunal or interim case tribunal, and any report from the Monitoring Officer on any matter which is referred by an ethical standards officer to the Monitoring Officer;
- (h) dealing with any complaints of failure by a Councillor to comply with any local Protocol;
- (i) monitoring the operation of this Constitution and recommending to the Council on any changes to this Constitution;
- (j) receiving reports from the independent remuneration panel and making recommendations to the Council on members' allowances. Such recommendations will be referred to the Cabinet for comment before being submitted to the Council;
- (k) making recommendations to the Council on the adoption and amendment of any Code of Conduct for officers. Such recommendations will be referred to the Local Joint Consultative Committee before being submitted to the Council;
- (I) preparing and advising upon the preparation of Working Guidelines as guidance to Councillors and officers in the discharge of their functions;
- (m)considering and making recommendations to the Council and the Cabinet in respect of any matter which has been referred to the Committee for consideration; and
- (n) the exercise of (a) to (g) above in relation to the Parish and Town Councils wholly or mainly in its area and the members of those Parish and Town Councils.

What have we been doing since January 2006?

Role of the Standards Committee in adopting the new Constitution

The Standards Committee has monitored the implementation of the new Constitution, and has recommended changes to the Council. We have agreed to involve the Scrutiny Committee and Cabinet and have agreed a process to be initiated involving members and officers to ask for any further issues to be identified for consideration.

Code of Conduct

We have considered the ODPM's conclusions arising from the consultation exercise on the review of the Code of Conduct in English Local Government. The outcome of this is that the Standards Board for England will focus on a central strategic role to promote consistently high standards of conduct. This will result in a continuation of the trend of referring an increasing number of cases for local investigation and determination. The Standards Committee examined the implications, and considered the evidence that showed an increased cost burden on the Council. These costs we queried direct with the Standards Board and received a less than satisfactory response. We shall continue to monitor and where possible protect the Council's position where we are able.

Local Determination Hearing

In May 2006 a hearing panel comprising five members of the Standards Committee successfully conducted its first local determination hearing into the conduct of two town councillors. The hearing was a learning experience for everyone concerned as we endeavoured to apply and administer the procedural rules prescribed by the Standards Board for England. Perhaps as a consequence of our collective inexperience and certainly in the interests of fair play the Chairman decided to adjourn the first hearing to allow more time for information to be gathered and further witnesses to be present.

When the hearing was resumed the Standards Committee resolved that one of the councillors had not been disrespectful and had not brought his office or authority into disrepute. The second councillor was found by the Standards Committee to have failed to treat others with respect and had brought his office and authority into disrepute.

Many lessons were learned which will be invaluable for the future although we all hope that the need for future hearings will be minimal.

Complaints Procedure

The Standards Committee has received a report on the Council's complaints procedure and the monitoring that has taken place. Copies of any reports concerning complaints which are presented to both Cabinet and Scrutiny, will also be monitored by the Standards Committee.

Methodology for Granting Dispensations

The Standards Committee has received a report on the methodology of granting dispensations.

Planning Applications submitted by Councillors

The Standards Committee approved an advice note to members on planning applications submitted by Councillors.

Learning and Development

In carrying out its role of advising, training or arranging to train councillors and co-opted members on matters relating to the Members' Code of Conduct and any local protocols, the Standards Committee has arranged the following over the past year:

- The screening of a DVD produced by the Standards Board for England explaining the process of investigations and hearings
- Training on Code of Conduct issues
- Training on Ethical Governance

Conclusion

Following the adoption of the new constitution earlier this year the role of the Standards Committee has been more clearly defined. We expect over the coming months to set out our own guidelines and targets for carrying out these duties and measuring and improving our performance.

We are also expecting, following changes in the working practices of the Standards Board for England, to be dealing with an increased proportion of the complaints made against councillors.

Whilst we are pleased with the progress made we realise that there is much more to be done. Changes in the National Code of Conduct and the way the Standards Board deals with alleged breaches of the Code will bring new challenges which will have to be dealt with by the Committee and may impact upon the numbers and membership of the Committee.

Above all we intend to be proactive in promoting ethical behaviour in local government in West Wiltshire.

To conclude I must thank all members of the Committee, past and present, who have contributed to its work, the District Councillors who have been so supportive especially to we "independent members" and the staff of the District Council for the help and information they provide and without whom we couldn't function.
