Purpose

- Negotiations between Wiltshire County Council (WCC) and Government Office South West (GOSW) are near completion regarding the new Local Area Agreement (LAA). This will form part of the Local Agreement for Wiltshire (LAW) which lays out how we will deliver real improvements for people and places in Wiltshire and achieve our 'big ambitions'.
- The LAA must be submitted to Central Government by the end of May 08 and the latest draft LAW is attached to this report. This report asks Council to delegate authority to the leader and Chief executive to make any minor changes to the LAW prior to it being signed, and for it to then become part of this Council's policy framework

Background

- The new national indicator set for local authority partnerships was announced as part of the Chancellor's Comprehensive Spending Review announcement in October 2007. The new national indicators will be the only means of measuring national priorities that have been agreed by Government and will apply where relevant to other local partners such as the Primary Care Trust and Police.
- The Wiltshire LAA is an agreement that sets out the priorities for a local area agreed between central government represented by GOSW and the local area represented by Wiltshire County Council. The LAW will show action and indicators agreed with our local partners to deliver real improvements for people and places in Wiltshire. The LAA will nestle within that and show targets against some of the indicators that we have agreed with central government. The LAA is the only place central government will agree targets with local government and will show:
 - > 16 statutory education and early years targets
 - > Up to 35 targets for other indicators from the National Indicator Set
- Whilst the LAA is required to be in place by the end of May 08, there was no requirement to have a LAW. However, the Wiltshire Strategic Board made the decision to have both for two main reasons.
 - 1. In Wiltshire, we have identified priorities outside of the National Indicator Set and want to ensure that they are not forgotten.
 - 2. The 200 new indicators do not always adequately capture the issues important to Wiltshire and could result in deflecting important resources and energy away from what we collectively really want to achieve.

- As a result of the State of Wiltshire debate in March 2007 the priorities ('Big Ambitions') for Wiltshire were endorsed as those outlined on Page 2 of the attached draft LAW:
- Action plans for each of these priority areas have been produced. However further work is required in agreeing appropriate targets and measures particularly where no base line figures currently exist.
- At the time of writing this report we are still awaiting government guidance to fully define some of the indicators in the National Indicator Set.

Key Issues

- The indicators and targets shown in the LAA are an agreement between Wiltshire County Council, its partners and government and will be used by government and inspectors to help assess Wiltshire's performance. Attaining the targets is likely to result in some reward money being paid to Wiltshire, but we are awaiting details of the scheme from government.
- 2. New governance arrangements to replace the Wiltshire Strategic Board have recently been agreed and these will help us to achieve the action and targets in the LAW and LAA.
- 3. It may not be possible to set targets for all LAA indicators for the first year of the agreement. This is because some indicators are completely new and so data has never been collected. In these cases, baselines will be developed during 2008/09 and targets, if appropriate, will be set from 2009/10.

Effects on Strategies and Codes

- Appendix 'B' highlights which indicators within the LAA are most relevant to this Council. It can be seen that the indicators where we will have the most involvement align well with our own corporate plan. These are:
 - Adult participation in sport and physical activity
 - Perceptions of anti-social behaviour
 - > Young peoples participation in positive activities
 - > 16-18 year olds who are not in education, employment or training (NEET)
 - Net additional homes provided
 - Number of affordable homes delivered (gross)
 - Residual household waste per household
- Officers have been involved in the negotiations regarding the LAW and its action plans. Any implications including resource allocation or changes to work plans have been included within service and financial planning for 2008/9.

Risk management implications

- Details of the new Local Area Agreement reward scheme are not yet known. This will be considered before targets are agreed with government. The proposals for each ambition have been subject to a 'challenge' process on the robustness of the planned action, and partners will be encouraged to use a common risk management approach.
- In the past some nationally imposed targets have been 'aspirational' to the point of being unattainable. In negotiating LAA targets with government we will be

mindful of the need to agree ambitious and achievable targets - not to agree targets that are unrealistic.

 In finalising the agreement, partners will be asked to commit to taking the action they have identified. The government's LAA regime states that responsible local authorities and [public sector] partner authorities are required to 'have regard' to all those targets which they have signed up to within the LAA. In order to fulfil this requirement government expects public sector partners to be able to demonstrate how they are effectively planning for the implementation of their contribution to the achievement of those targets to which they have signed up. This provision relates to a wide range of public sector partners named in the legislation and should help reinforce commitment to the LAA.

Financial Implications

- The LAA will not require any additional resources. However the LAA is part of a shift towards greater emphasis upon aligning budgets, pooled funding, collective responsibility and area assessment.
- Decisions regarding funding will increasingly sit with the new Wiltshire Strategic Board and will be focussed upon delivering the LAW. It is therefore vital that we are engaged fully in this process in order to deliver our own corporate priorities.
- There is likely to be an element of Reward Grant that the government will pay for achievement of targets in the LAA. The LAA ambitions include 'working together' which should help us to better align resources with our partners to achieve results. The proposals for new governance Thematic Delivery Partners are the powerhouses of the 'family' responsible for developing and delivering significant action to achieve the ambitions in the LAW, including the LAA. Wiltshire County Council will develop a work plan that addresses the Thematic Delivery Partnerships to ensure that there are sound financial management arrangements in place.

Legal and Human Rights Implications

- There are no significant human rights implications
- This Council is being asked to commit itself to some specific actions to help deliver the LAW. However this is not a legal agreement.


- 1. The Council is a signatory to the LAW and Wiltshire LAA.

Working together to achieve these ambitions

FIRST DRAFT

This Local Agreement for Wiltshire (LAW) will be updated by 31st May to reflect targets being agreed with government and for agreement with local partners on action to be taken. As part of this the language used under each of the ambitions will be simplified. A summary version will be produced later. **The ambitions for Wiltshire** are shown below. These have been approved by the Wiltshire Strategic Board and endorsed by Wiltshire County Council. The action to support these ambitions summarised in this document shows the commitment of the organisations within the County to work in partnership to achieve improvements for people and places in Wiltshire.


- a. Build 'resilient communities' with high social capital through people feeling socially included, enabling people and communities to build skills, abilities, knowledge and confidence to take effective action and play leading roles in the development of their communities and so enhancing their quality of life.
- b. Improve affordable housing
- c. 'Lives not services'- support more people to have independent and fulfilling lives as part of their local community; support families to provide the strong foundations for children and young people's development; enable individuals to make informed choices to improve their long term health and well being
- d. Wiltshire exhibiting a positive and sustainable environment for economic growth
- e. Reduce particular crimes, change behaviours and inform the public to bring about communities that are safe and feel safe
- f. Environment: Tackle climate change and promote a high quality, natural environment that enriches the lives of people
- g. Work together to achieve the ambitions, including new governance arrangements for the 'family of partnerships' and the establishment of community area boards.

The action summarised within this Local Agreement is designed to join up the work of partners and support several ambitions. For simplicity we have shown action once only, under the most appropriate lead ambition. More detailed action plans are held by the organisations leading on each action. The work under each of the ambitions contributes to social, economic and environmental sustainability.

To measuring progress on these ambitions we will use number of measures (indicators). Some of these are also of interest to central government and so nestled within this Agreement is our **Local Area Agreement** with government, showing the targets we have agreed.

Working together to achieve the Ambitions means that we develop action that supports several ambitions. It is clear how the other ambitions help create 'resilient communities' that can thrive, and how 'resilient communities' contributes to the other ambitions. Our approach has been to try to ensure that the ambitions also support each other to create a stronger more joined-up approach to the Local Agreement. Some examples of this are:

- Affordable Housing and Lives not Services: appropriate housing is a contributor to independent living and good health
- Lives not Services and Safer Communities: young people being less likely to be victims or perpetrators of crime; the impact of drug and alcohol treatment on reducing persistent re-offending; increased feelings of safety
- Safer Communities and Environment: intergenerational activities and feelings of safety in communities
- Environment and Lives not Services: health benefits of use of the countryside; intergenerational activities and community cohesion
- Lives not Services and Economic Growth: more people into employment
- Economic Growth and Affordable Housing: the availability of appropriate accommodation for employees is important to businesses, particularly for key workers
- Affordable Housing and Safer Communities: people in suitable accommodation tend to feel safer, and are safer
- Safer Communities and Economic Growth: Reduced worklessness and lower deprivation
- Economic Growth and Environment: lower out-commuting and CO₂ emissions
- Environment and Affordable Housing: more energy efficient homes help to reduce CO₂ emissions



1. Build 'resilient communities' with high social capital through people feeling socially included, enabling people and communities to build skills, abilities, knowledge and confidence to take effective action and play leading roles in the development of their communities and thereby enhancing their quality of life.

Action:

- 1. Engage all our communities in Wiltshire, inclusively, to ascertain their priorities and empower them to be integral to the delivery of solutions. This will make their community a better place to live and or work.
 - Strengthen our community planning infrastructure
 - Develop an equalities organisation to fully represent the 6 equality strands
 - Establish Wiltshire Financial Inclusion Taskforce debt advice, benefits take-up, informed choices
 - Seek community engagement in intergenerational sport and cultural activities
 - Consult with local communities to seek local solutions to ensure improved access to essential services

<u>Places and people</u>: Target areas of deprivation including pockets of rural need across Wiltshire.

- 2. Enhancing the democratic framework in Wiltshire by which people can participate in their local area and feel they can influence the decisions made in their locality
 - Establish an effective model of community governance with Community Boards working alongside Community Area Partnerships in each of Wiltshire's 20 community areas
 - Build the capacity of Town and Parish Councils to engage in the new arrangements for local democracy.
 - In partnership with communities develop a positive culture that encourages civic participation and develops the role of frontline councillors and other community leaders.
 - Improve customer access to information and services e.g. through a single point of contact for information on public services such as 'Ask Jeeves' or 'Start Here' websites.

Places and people: All community areas

- 3. Build a vibrant, strong and influential third sector across Wiltshire
 - Take forward the review of the relationship between the public sector and the voluntary and community sector
 - Build on the capacity and skills of the Voluntary Sector Forum in Wiltshire to become an influential voice which represents the sector effectively.
 - Implement a programme to increase the profile and awareness of Wiltshire's Compact.
 - Agree a way forward increasing investment and opportunities for volunteering across Wiltshire.

<u>Places and people</u>: Third sector and public sector partners in Wiltshire.

- 4. Action from the Children and Young People's Plan to:
 - Improve educational attainment and narrow attainment gaps
 - Enable young people to participate in a broader range of positive activities and play, be involved in service development and delivery Things/Places/People

<u>Places and people</u>: All children and young people, all community areas.

- 5. Based on the findings of the Joint Strategic Needs Assessment, develop models for improving local community support and engagement for older people and people with disabilities (year one). Support and promote the engagement of disabled people, older people and carers in their local communities, through:
 - Volunteering, befriending and other local networking
 - Support for strongly-co-ordinated user and carer organisations to offer support, advice and information and to influence service development
 - Implement the LINk
 - Work with the CVSs to evaluate 3rd sector preventative services

<u>Places and people</u>: Disabled people, older people and carers, all community areas.

Measures: (*those currently shortlisted for LAA)

* NI 1 Percentage of people who believe that people from different backgrounds get on well together in their local area

* NI 4 Percentage of people who feel they can influence decisions through their locality

* NI 6 Participation in regular volunteering

- * NI 7 Environment for a thriving third sector
- * NI 8 Adult participation in sport
- * NI 110 Young people's participation in positive activities
- * NI 130 Social care clients receiving self directed support
- * NI 135 carers assessments and services

* In addition there are 16 statutory education and early years targets that must be included in the Local Area Agreement (LAA) with central government. 2. Improving affordable housing

Action:

- 1. More New Affordable Homes: to enable a significant and lasting increase in the number of affordable homes together with the improved delivery of new homes to meet the economic and housing needs of the county's strategically significant centres
 - Carry out an audit by 31/12 2008 of land held by the local authorities in Wiltshire, other public bodies and housing association partners to identify sites where Affordable Homes could be built up to 2011.
 - Review the three Housing Market areas covering Wiltshire with GOSW/ Housing Corporation/SWRA to identify if this should be represented. Develop a monitoring protocol.
 - Establish a Housing Partnership Board; Develop a Strategic Housing Partnership Agreement with the Housing Corporation.
 - Evaluate the benefits of establishing a Local Authority delivery vehicle.
 - Evaluate and if appropriate promote Community Land Trusts.
 - Review the Registered Social Landlord preferred partnerships across Wiltshire.
 - To publish a criteria for the assessment of RSL development and management of new homes.
 - Review Strategic Housing Market Assessments for Wiltshire.
 - Develop a viability assessment model.
 - Standardise and develop good practice for Section 106 agreements including a consistent approach to negotiating 'affordable housing'.
 - Identify the potential of acquiring existing properties for affordable housing e.g. Ministry of Defence properties.
 - Publish a new Housing Strategy for Wiltshire.

<u>Places and people</u>: All areas of identified need across Wiltshire with a focus on Salisbury, Trowbridge and Chippenham. Households who are unable to afford to access the private housing market to secure a suitable home; older people seeking to move to a more suitable home so as to continue living independently; young people requiring accommodation with support; vulnerable households living in poor quality private housing.

2. Helping Homeless people: to reduce the number of people facing homelessness by offering genuine alternative housing and support options that help people move on in a planned way to more independent living.

- Mainstream young people's accommodation and support service so that specialist support is available to prevent emergency provision. Establish a Young Persons Accommodation and Support Board. Launch Young Persons' web site.
- Establish a Wiltshire Pathway for single homeless people who can access appropriate accommodation and support.
- Review Supporting People Strategy to ensure resources are targeted to those most in need of accommodation with support.
- Review the provision of temporary accommodation across Wiltshire.
- Ensure a consistent approach to front-line homelessness intervention, prevention and options. Publish a Wiltshire Homelessness Strategy.
- Launch Homes 4 Wiltshire.

<u>Places and people</u>: Throughout Wiltshire but the focus will be in the areas of Chippenham, Salisbury, Devizes and Trowbridge. Households who are unable to afford to access the private housing market to secure a suitable home; older people seeking to move to a more suitable home so as to continue living independently; young people requiring accommodation with support; vulnerable households living in poor quality private housing.

- 3. Greener and accessible affordable homes: to ensure that through good design we create more lasting homes; homes that are environmentally friendly and homes that will support independent living.
 - Develop and publish a Sustainable Homes Criteria (in accordance with the Sustainable Homes Code) to influence and direct the standards required and expected for the delivery of new affordable homes.
 - Identify vulnerable households in existing properties and to target energy efficiency measures that reduce fuel poverty and contribute to reducing carbon emissions.
 - Identify vulnerable households who are at risk of falls and whose homes require safety improvements to be delivered through better use of home improvement grants.

<u>Places and people</u>: Throughout Wiltshire. Households who are unable to afford to access the private housing market to secure a suitable home; older people seeking to move to a more suitable home so as to continue living independently; young people requiring accommodation with support; vulnerable households living in poor quality private housing.

Measures: (*those currently shortlisted for LAA)

*NI 154 Net additional homes provided *(Enable the completion of XXXX new homes by 2011 in particular at Trowbridge, Chippenham and Salisbury and for further XXXX to achieve a detailed planning consent each year up to 2013*

Housing and Land supply: Through the Strategic Land Availability Assessments identify sufficient land to deliver XXXX homes between 2011 and 2016)

*NI 155 Number of affordable homes delivered (gross) (New sustainable affordable homes: enable the completion of XXX new affordable homes by 2011 and XXX in each year between 2011 and 2013. Temporary accommodation: halve the use of Homeless temporary accommodation between 2008 and 2010

Milestones to monitor progress against actions are included in the detailed action plans that support this Local Agreement.

<u>Who will lead on this</u>? [to be updated – currently a mix of lead and contributing bodies] District Councils, County Council, The Housing Corporation, Registered Social Landlords, Wiltshire Primary Care Trust, Parish Councils, MOD, Home Builders Federation / Developers, 3rd sector Voluntary groups involved in homelessness and special needs groups

3. Lives not services - support more people to have independent and fulfilling lives as part of their local community; support families to provide the strong foundations for children and young people's development; enable individuals to make informed choices to improve their long term health and well being

- 1. Improve working across health and social care to provide more appropriate and local services, which help people recover and prevent them being in hospital unnecessarily, or needing long-term care.
 - Complete older people's accommodation strategy with the PCT, District Councils and Registered Social Landlords and take action, including short stay 'reablement units' where people can recover from hospital and extra care housing.
 - Evaluate the new reablement service and improve the way this service links to local health services.

- Develop preventative services such as telecare services to provide alarms and response service
- Coordinate information to the public about health and care options and improve information to the public about alternatives to long term care.

Places and people: Older people across Wiltshire.

2. Improve access to assessments and services for carers and involve carers in developing services

Places and people: Carers across Wiltshire.

3. Support more people through direct payments/individual budgets to manage own care

Places and people: All client groups across Wiltshire.

4. Improve access to services for people with dementia

<u>Places and people</u>: People across Wiltshire with mental health problems in later life.

5. Improve access to primary care services for people with learning disabilities

Places and people: Adults with learning disability living in Wiltshire.

6. Action from the Children and Young People's Plan to improve services for disabled children and young people

<u>Places and people</u>: Disabled children and young people living in Wiltshire.

- 7. Encourage people to make lifestyle changes that will have a positive impact on the health of both themselves and their families:
 - Encourage people to make lifestyle changes by providing a multi layered training programme in Wiltshire for staff from a range of agencies who can support the public in making healthier choices.
 - Develop weight management referral schemes and improve existing exercise referral scheme across the county in areas where they are most needed
 - Develop a range of community initiatives to encourage people to make healthier choices

<u>Places and people</u>: All community areas, and especially deprived communities to reduce inequalities in health, including lower super output areas: Calne Abberd - south; Chippenham Queens - east; Devizes North east; John of Gaunt - Studley Green; Melksham North - north east and south west; Trowbridge Adcroft - Seymour; Trowbridge Drynham – central; Trowbridge Drynham - Lower Studley; Salisbury Bemerton - west and south; Salisbury St Martin - central; Westbury Ham - west; Wootton Bassett North - central (community areas: Trowbridge, Salisbury, Westbury, Melksham, Calne, Wootton Bassett, Chippenham, Devizes). Rural areas. Children, their families and the wider community. All individuals with a health condition where exercise can play in part in managing/improving the condition eg obesity; high blood pressure; osteoporosis; low back pain; depression; diabetes; CHD (certain conditions only). Communities described as 'hard to reach' and Erlestoke Prison. 8. Implement a universal Chlamydia screening programme for under 25s

<u>Places and people</u>: All community areas. Sexually active young people aged 15-24 years living in Wiltshire.

- 9. Work with particular communities in Wiltshire, in our most deprived areas, to understand their health needs and what they require to support them in avoiding ill health. Alongside this, implement a scheme of preventative work to influence the main causes of ill health and early death, focussing on major killers (cardio-vascular disease (CVD and cancers). The key causes of CVD and cancer include smoking, unhealthy diet/excessive alcohol use and a sedentary lifestyle. Preventative work to enable people to make healthier choices about their lifestyles will include:
 - Identifying the areas where this work is most needed (eg from GP practice profiles).
 - Ensuring the stop smoking service reach those who need it most.
 - Developing an obesity strategy and implementing its action plan.
 - Implementing the action plan of the Wiltshire Alcohol Strategy.
 - Implementing a healthy workplace scheme.

<u>Places and people</u>: Areas identified by the Joint Strategic Needs Assessment (JSNA), GP practice populations with higher rates of CVD/Cancer, and deprived communities (see above). People most at risk.

10. Action from the Children and Young People's Plan to improve sexual health, support mental well-being, promote resilience, reduce substance misuse, and tackle obesity and improve healthy eating and exercise.

Places and people: Children and young people living in Wiltshire.

Measures: (*those currently shortlisted for LAA)

<u>Who will lead on this</u>?: [to be updated – currently a mix of lead and contributing bodies] Wiltshire PCT and Wiltshire County Council with Acute Trusts; Carers and carer support organisations; Children's Centres; community area groups; District Councils; DWP; Healthier Wiltshire stakeholders; independent service providers; leisure providers; local employers; local residents associations and other such groups; Mental Health Trust; Primary Care; voluntary sector; Wiltshire Community Services (PCT provider);; Wiltshire Wildlife Trust.

4. Wiltshire exhibiting a positive and sustainable environment for economic growth

1. Improve business productivity through innovation – provide businesses with specific advice, information, knowledge events and other support.

<u>Places and people</u>: Small and medium sized businesses across Wiltshire.

Lead partner(s): Wiltshire Strategic Economic Partnership (WSEP Innovation Group; Business Link.

2. Research to assess the significance of planned military changes for communities and civilian and military authorities. This is part of the larger Military Civilian Integration Programme which is designed to maximise the economic and social benefit of the MoD presence in Wiltshire. The current research will provide a baseline for future service delivery.

<u>Places and people</u>: Communities impacted by the military - Tidworth, Durrington, Corsham, Bulford, Wilton, Warminster and Lyneham.

Lead partner(s): Wiltshire County Council; Defence Estates; Jobcentre Plus (JCP); Learning and Skills Council LSC); Army.

3. Tackle pockets of worklessness to help provide an adequate labour supply to meet business demands through raising skills levels, including basic and employability skills, and working with hard to reach groups. To include improving the take-up of training programmes, developing and launching specific worklessness projects, implementing detailed strategies addressing NEET issues and work with adult social care to support disabled people into employment.

<u>Places and people</u>: hard to reach groups e.g. lone parents, adults with LDD, NEETs, offenders, over 50s, those in disability benefits focussing on, variously, designated wards (<u>Kennet</u>: Devizes East & North; Pewsey; Tidworth; <u>North Wiltshire</u>: Calne Abberd; Pickwick (Corsham); <u>South</u> <u>Wiltshire</u>: Bemerton; St Edmund & Milford; St Martin & Milford; <u>West</u> <u>Wiltshire</u>: Melksham North & Melksham Spa; Trowbridge Adcroft; Trowbridge Drynham; Westbury Ham), customers of children's centres. NEETs - Wiltshire wide (with focus on Trowbridge, following trend data). Disabled people, Wiltshire wide.

Lead partner(s): JCP; LSC; Connexions; Wiltshire County Council.

4. Broaden the employment base of Wiltshire, increasing higher value and higher skilled jobs and extending Higher Education (HE) provision in the County – develop Wiltshire-wide employment and investment strategies and a HE plan; improve take-up of higher level skills training; conduct research to examine the potential of using skilled migrant workers to address labour market deficiencies; implement a co-ordinated service to support businesses looking to invest in Wiltshire.

<u>Places and people</u>: Wiltshire-wide employers; EU transnational workers and new investors in Wiltshire

Lead partner(s): Wiltshire County Council; LSC; WSEP Investment Group.

5. Work with the private sector to provide adequate workspace and employment land provision to meet market needs, including incubation space and the development of centres of excellence – develop a workspace strategy; research the development of/develop specific workspace facilities in key locations.

<u>Places and people</u>: Wiltshire-wide with a focus on strategic sites and key settlements, to encourage investors; Rural Enterprise Centre (REC) – to include food and farming, and landscape/ environmental based businesses; Castledown Business Park - high growth small businesses; Porton Down Bioscience Technology Centre - bioscience sector; Porton Down Public Sector Science Park -High technology public sector agencies.

<u>Lead partner(s)</u>: Wiltshire County Council; District Councils; WSEP Investment Group.

6. Improve journey time reliability on strategic transport routes in Wiltshire

<u>Places and people</u>: Wiltshire wide along strategic transport routes (A350), supporting businesses and commuters

 Research to understand how key settlements can evolve/regenerate as thriving and vibrant economic centres – this could include a SWOT analysis for each key settlement and is likely to involve community consultation on findings.

Places and people: Wiltshire-wide

5. Reduce particular crimes change behaviours and inform the public to bring about communities that are safe and feel safe

1. Public reassurance through consistent and regular communication with communities to increase the feelings of safety

<u>Places and people</u>: This action will aim to provide information to communities, victims and witnesses across the whole of Wiltshire wide,

with particular attention on those areas expressing more concern following surveys and consultation.

2. Reduce reoffending by joining up services such as housing, education, and health (mental health and drugs and alcohol) for prolific and priority offenders and ex-offenders. Give due regard to the prevention of the transition of young offenders into the adult criminal justice system

<u>Places and people</u>: This relates primarily to Probation Clients, Prolific and priority Offenders (PPO's) and Young offenders and will be implemented in all areas of the County

3. Improve streetscene by working together in communities on street clean ups, community events, safety messages and to reduce crime and antisocial behaviour (ASB). Intergenerational work eg through leisure and the arts as well as activities for young people.

<u>Places and people</u>: Those most at risk of being perpetrators or victims of ASB e.g. alcohol related offenders, young people, communities perceiving ASB as a problem in their area and communities where trigger crimes or identified disorder eg fires are most prevalent

4. Tackle domestic violence by challenging attitudes to domestic violence, increasing reporting and providing earlier intervention and commissioning appropriate services to support victims and their children

<u>Places and people</u>: This action targets two main groups; children and young people and victims of domestic violence and will apply throughout Wiltshire

- 5. Reduce alcohol related crime and harm, particularly violent crime and antisocial behaviour through 4 strands of activity: prevention, intervention, enforcement, resettlement and rehabilitation. This includes action to:
 - Reduce the percentage of people who perceive drunk and rowdy people to be a problem in their area.
 - Reduce the levels of chronic and acute ill health caused by alcohol, resulting in fewer alcohol related accidents and hospital admissions.
 - Reduce the level of alcohol related harm to children and young people.
 - Raise awareness of sensible drinking.
 - Improve the management and planning of the night time economy.

Places and people: Wiltshire wide

- 6. Reduce road traffic collisions in Wiltshire by understanding the reasons for the high rates of serious injury and death as a result of road traffic collisions in Wiltshire and implementing measures to reduce these, and implement local actions arising from recently published "Staying Safe" Action Plan:
 - Improve joint and strategic working by developing and monitoring progress against a joint strategy and action plan and use Children's Trust arrangements (eg LSCBs) as a vehicle to oversee and ensure delivery of prevention strategies.

- Regularly review and develop a clear understanding of the rates and types of accidents in Wiltshire, to enable actions and resources to be directed accordingly.
- Tackle health inequalities in accident rates by using Office of National Statistics data, target health promotion initiatives at areas of deprivation.

<u>Places and people</u>: All community areas, whole population.

Climate change will effect us all and we all need to both reduce its causes and prepare for its impacts. Tackling climate change contributes to social and economic objectives as well as environmental. A lower carbon society resilient to climate change will also be a happier more cohesive society.

1. Increase uptake of energy efficiency and renewable energy measures.

Places and people: All community areas, all households.

2. Reduce carbon emissions from public sector business through efficiency measures, new technology and improved management practices.

Places and people: County wide, Council staff and partners

 Increase use of sustainable energy measures in new developments (encouraged by planning policy) and delivered through planning development control decisions

Places and people: Wiltshire wide

4. Reduce carbon emissions from transport through more balanced development, sustainable transport, and demand and traffic management and new technology

Places and people: Residents, businesses and visitors. Wiltshire wide.

5. Improve the reduction, re-use and recycling of household waste through increased participation by the community, including so called hard to reach groups

<u>Places and people</u>: Wiltshire wide. All people, with particular to focus on older people, young people, and people with disadvantages due to educational attainment, language difficulties or lack of confidence about using the service

Adaptation to climate change brings opportunities which will be promoted to the appropriate sectors. For example reduced international travel creates business opportunities within the county around recreation & tourism targeted at the domestic market. Adaptation action would focus on groups identified as vulnerable to climate change e.g. the elderly and very young.

6. Increase awareness of climate change adaptation leading to action being taken by individuals, communities and businesses

<u>Places and people</u>: Wiltshire wide, individuals, communities and businesses

Wiltshire's exceptionally high quality natural environment is one of our greatest assets. It brings a range of social and economic benefits from supporting and encouraging healthy lifestyles to supporting the rural economy through tourism and recreation. Throughout the county we need to ensure that this natural asset is understood, conserved and enjoyed. We also need to ensure that new developments both enhance it and allow greater access to it.

7. Targeted conservation and enhancement of Wiltshire's biodiversity in line with the Wiltshire Biodiversity Action Plan and the South West Nature Map; in particular improve monitoring, advice, and management of County Wildlife Sites, where possible through community action. Ensure high quality biodiversity information is available to decision makers

<u>Places and people</u>: All areas. Outcomes benefit all sections of the community. Wiltshire's natural environment is widely and potentially accessible, but there are barriers to access, and there are opportunities to focus on excluded groups.

8. Ensure new developments are designed for greater community cohesion, to promote physical and mental health, reduce crime and enhance wildlife

<u>Places and people</u>: Primarily at and around sites of new development in the county (typically adjoining the county's towns). This will particularly benefit people with limited transport opportunities such as children and other less mobile groups for whom access to the wider countryside is difficult. Energy efficiency will benefit residents suffering fuel poverty, and reduce CO_2 /climate change.

The Wiltshire Assembly - the new Local Strategic Partnership. Membership is wide and inclusive including representatives of communities, organisations and sectors across the county and relevant regional bodies. Independent chairman. Hosts the 'State of Wiltshire Debate' to inform the ambitions for Wiltshire, and sets challenges for Wiltshire's partnerships and organisations.

The Wiltshire Strategy Group (WSG) - a small working group coordinating action on the Community Strategy and the Local Agreement. Representatives from the Thematic Delivery Partnerships and WFCAP - looking at issues and joining up action across partnerships and areas. Chaired by the Chief Executive of the Council and accountable to the Accountable Bodies Group.

The Accountable Bodies Group (ABG) bringing together key public sector organisations that allocate significant resources to Wiltshire and are held accountable by government. The membership will largely comprise elected Members and Chairmen with authority to commit resources on behalf of their organisations. It will agree strategy and commitment from those organisations and agree the LAA. Chaired by the leader of the Council and held to account by Wiltshire Council as accountable body.

Thematic Delivery Partnerships - the powerhouses, responsible for developing and delivering significant action to achieve the ambitions.

Community Areas - Community Area Partnerships are the means by which the 'family of partnerships' links county strategies and action with local priorities and action. Each community area is represented on the Wiltshire Assembly, and by WFCAP on the Strategic Group. The role of the Community Boards will be reflected in the membership of the Accountable Bodies Group by the Cabinet member responsible for community working.

Measures: The success of the new arrangements will be reflected in the measures shown elsewhere in this Agreement.
