**NOMINATIONS FOR AREA PLANNING COMMITTEES
IN THE PRE-ELECTION PERIOD**

Executive Summary

On 13 November 2008 the Implementation Executive considered a report outlining options in constituting area planning committees and the legal requirements in appointing members to serve on them, both in the pre-election period from 1 April until the elections in June 2009, and for the new Council.

As set out in detail in paragraph 3 of the report, the IE agreed that for area planning committees in the pre-election period that political proportionality be waived, and that instead in West Wiltshire, North Wiltshire and Kennet areas, the current members of the District Council Development Control Committees be asked to serve as co-opted members on the Area Planning Committee for their area; and that Salisbury District Council be asked to nominate between 12 and 15 members of their current Area Committees, which have development control responsibilities, to be co-opted to serve on one Area Planning Committee for the whole of the Salisbury area.

This further report asks the IE to formally co-opt members who have confirmed that they are willing to serve on the relevant planning committees during the pre-election period. The IE will have to specify by resolution the name of each individual concerned.

Proposal

That the Implementation Executive co-opt individual current district councillors to serve on their respective area planning committees in the pre-election period as listed in paragraph 5 of the report.

Reason for Proposal

Planning committees will have to be constituted for the pre-election period from April to June 2009 to continue to deliver a development control service.

NOMINATIONS FOR AREA PLANNING COMMITTEES IN THE PRE-ELECTION PERIOD

Purpose of Report

1. This report asks the Implementation Executive to formally co-opt members who have confirmed that they are willing to serve on their relevant planning committees during the pre-election period from April to June 2009. The IE will have to specify by resolution the name of each individual member concerned.

Background

2. On 13 November 2008 the Implementation Executive considered a report outlining options in constituting area planning committees and the legal requirements in appointing members to serve on them, both in the pre-election period from 1 April until the elections in June 2009, and for the new Council.
3. Subject to the Local Government (Structural Changes) (Transitional Arrangements) (No. 2) Regulations 2008, the Implementation Executive agreed that for area planning committees in the pre-election period the political proportionality be waived, and that instead
 - (i) in West Wiltshire, North Wiltshire and Kennet District Council areas, the current members of the District Council Development Control Committees be asked to serve as co-opted members on the Area Planning Committee for their area with the existing terms of reference and geographic responsibility; and
 - (ii) Salisbury District Council be asked to nominate between 12 and 15 members of their current Area Committees, which have development control responsibilities, to be co-opted to serve on one Area Planning Committee with the existing terms of reference but with geographic responsibility for the whole of the Salisbury District Council area.
4. The district councils subsequently confirmed with their development control committee members if they would like to continue to serve on their respective committees during the pre-election period. The individual councils' nominations can be found below.

Main Considerations for the Implementation Executive

5. Single development control committees are currently in operation in the West Wiltshire, North Wiltshire and Kennet district council areas and the following members have been nominated to serve on an area planning committee in the pre-election period:

8. Continuing with four area planning committees during the pre-election period improves accessibility to the decision-making process.

Risk Assessment

9. Using existing qualified and experienced district council members ensures continuation of the development control service and should reduce the risk of any decisions being re-viewed at a later stage.

Financial Implications

10. The Members Remuneration Panel will shortly consider the issue of allowances for co-opted members of the district councils who are asked to continue to serve in the pre-election period.

Legal Implications

11. Planning committees have to be constituted for the pre-election period from 1 April 2009 to June 2009 in order to discharge the Council's responsibilities in relation to development control. The proposed arrangements are made in accordance with paragraphs 15-17 of the Local Government (Structural Changes) (Transitional Arrangements) (No. 2) Regulations 2008, which came into force on 28 November 2008.

Conclusion

12. After the Implementation Executive formally co-opted individual current district members to area planning committees, the development control service can be continued in the pre-election period.
